SUBJECT Enforcement Division Report

### **STAFFING**

The Enforcement Division currently has multiple staff members out on various types of leave, and recently had one Staff Services Manager I (SSM I) retire, and another promote. We are working to hire the SSM I for the Probation Unit, and two Program Technician III's for the Licensee Applicant Case Review Unit (LACRU).

### **Statistical Overview**

Attached is the BVNPT Enforcement Report - This report includes statistical data from 2018 to March 31, 2022.

### **Notable Highlights:**

#### **Total Number of Investigations Assigned**

The total number of cases assigned for investigation in the 2021 Fiscal Year (FY) is 1758 cases. Currently, we have assigned a total of 1175 for the first three quarters of 2022 FY.

#### **Total Number of Pending Cases**

The total number of pending investigation cases decreased from 942 cases in the first quarter of the 2022 FY to 924 cases in the third quarter of the 2022 FY. The total average pending age of all pending investigation cases decreased from 262 to 261 days.

### **Total Number of Investigations Completed**

The total number of investigations completed decreased from 494 in the first quarter of the 2022 FY to 462 in the third quarter of the 2022 FY. The average number of days to complete investigations decreased from 235 days to complete to 226 days to complete.

### **Total Number of Cases Referred to the Attorney General's Office**

During the first quarter of the 2022 FY we sent 65 cases to the Attorney General's Office. During the third quarter of the 2022 FY we sent 24 cases to the Attorney General's Office.

### **Total Number of Disciplinary Cases Completed**

During the third quarter of the 2022 FY 54 disciplinary actions were completed. The average number of days to complete these actions was 760 days.

### **Licensee Probation**

During the third quarter of the 2022 FY, there were 36 new probationers. The average number of days from assignment to first contact was three days.

### **Ongoing Issues Due to COVID-19**

While the Enforcement Division is diligently working on closing cases, we may continue to see case aging issues if the courts do not re-open fully or continue to maintain a sizeable backlog. Since Enforcement relies heavily on local and federal courts for our criminal cases, delays may occur as we have no control over how the courts set their hearing calendars.

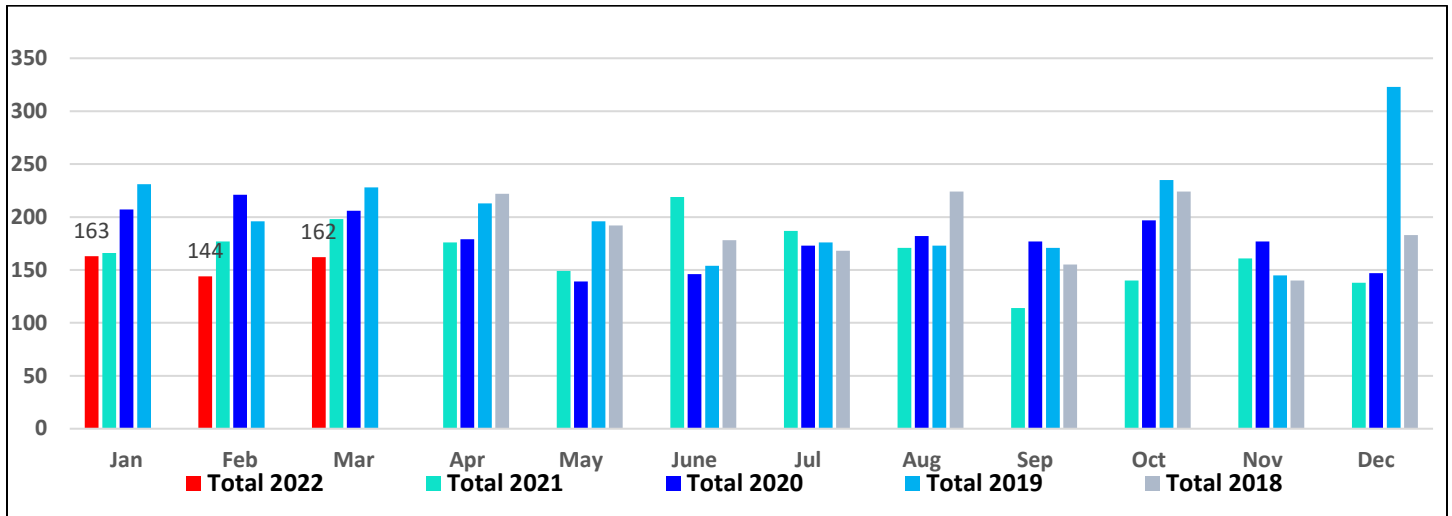

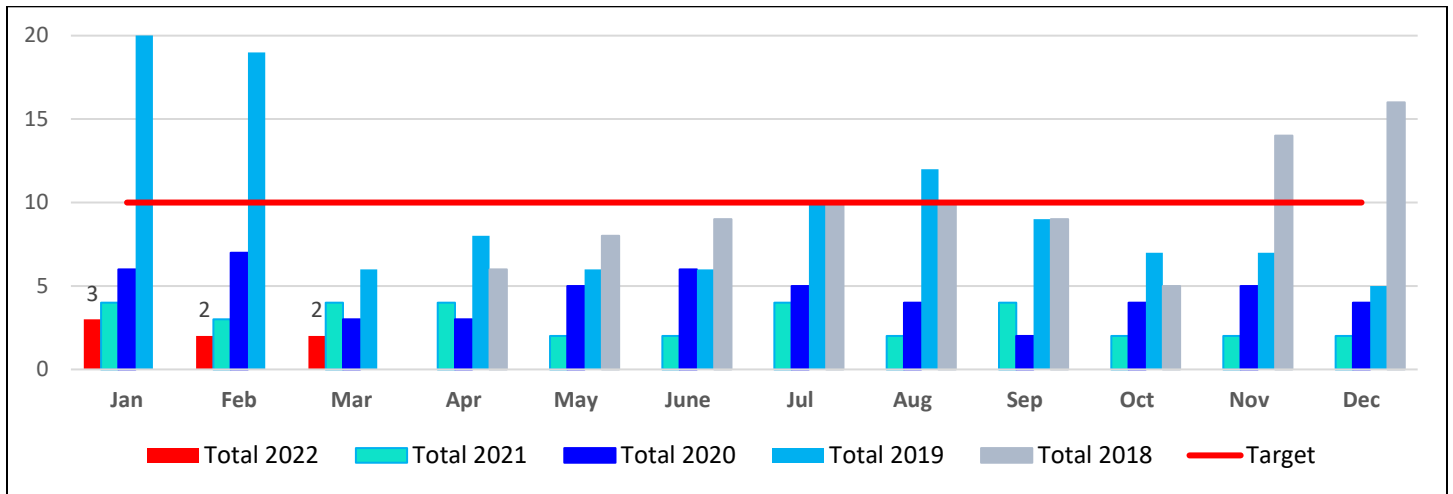

### PM1 – Total Intake Received

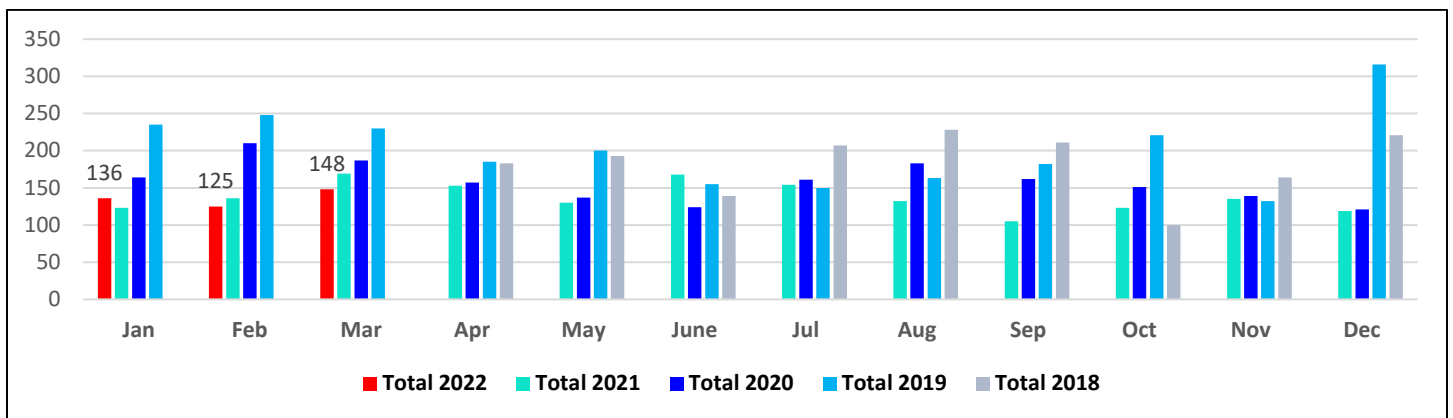


## PM2 – Average Days to Assign/Close

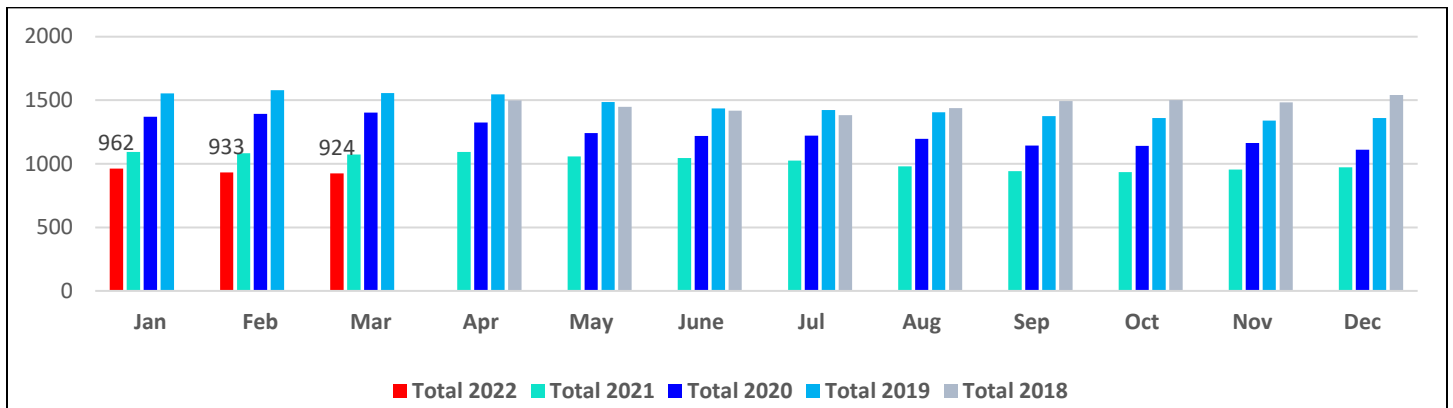

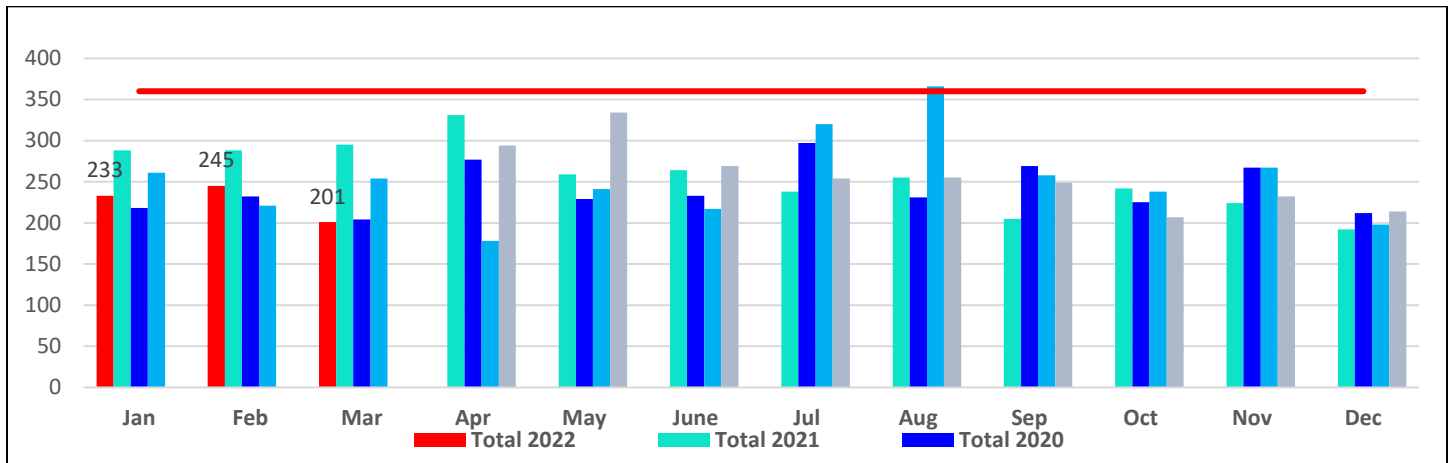

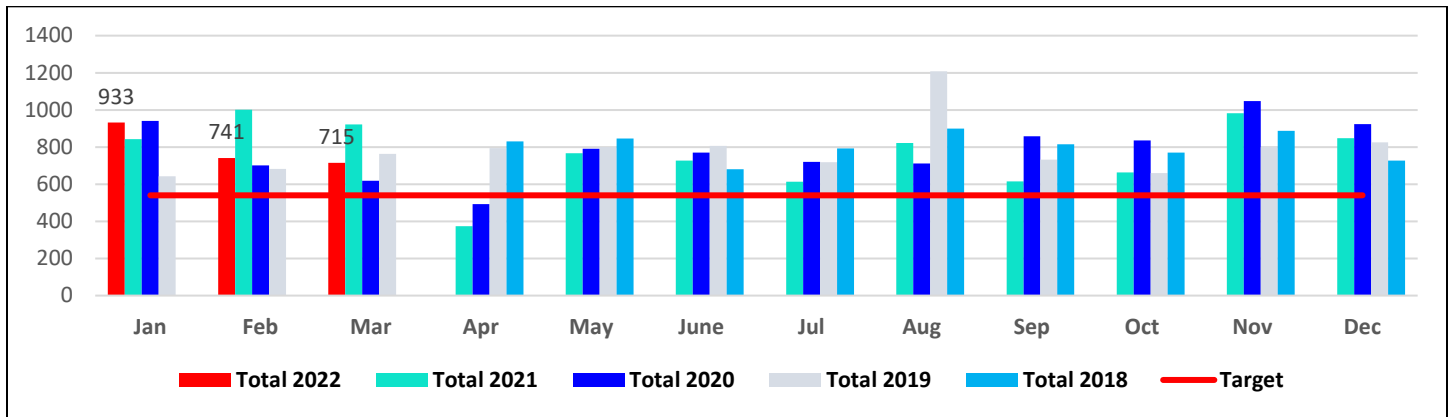

## PM4 – Average Days to Complete Discipline

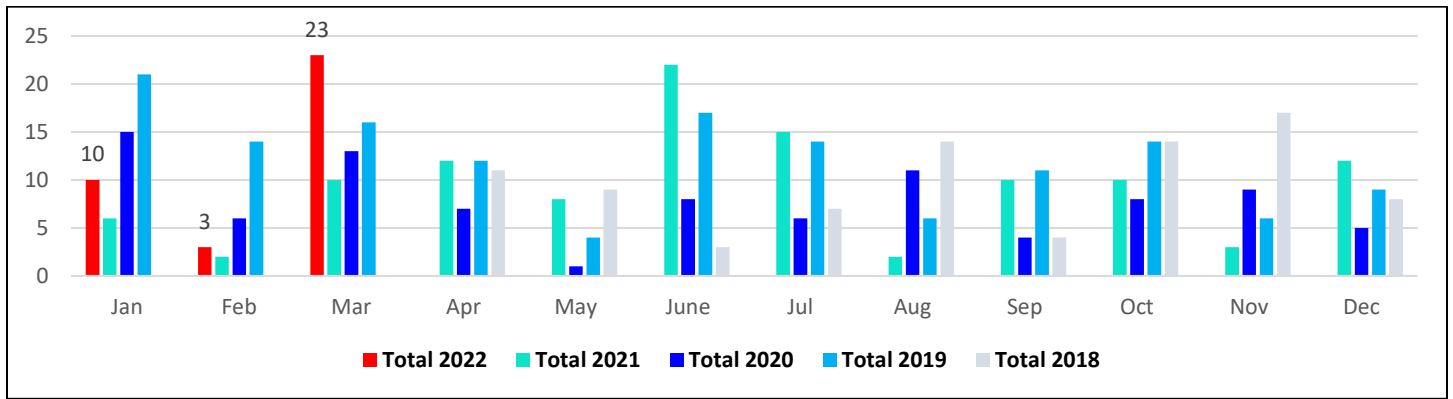

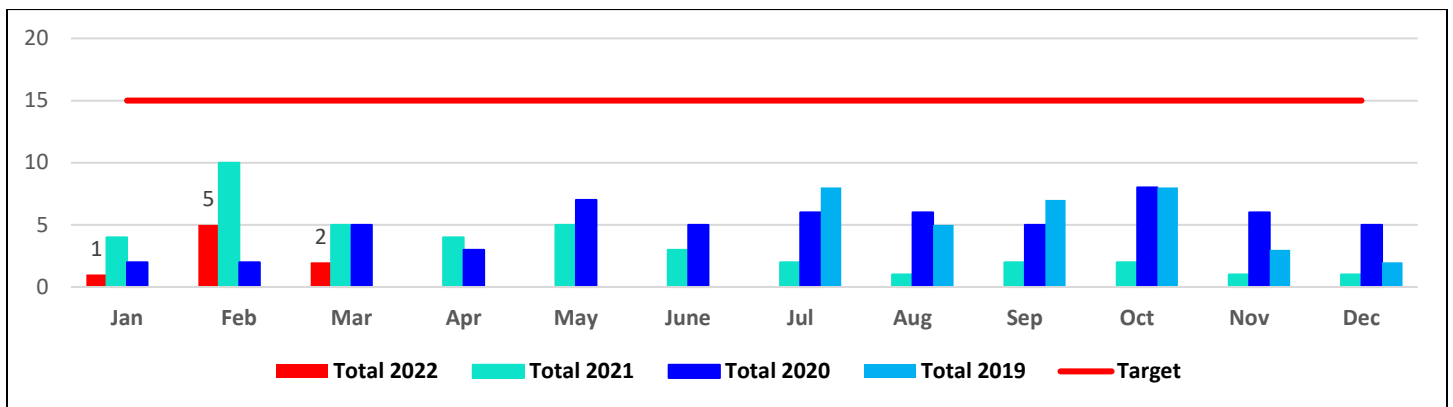

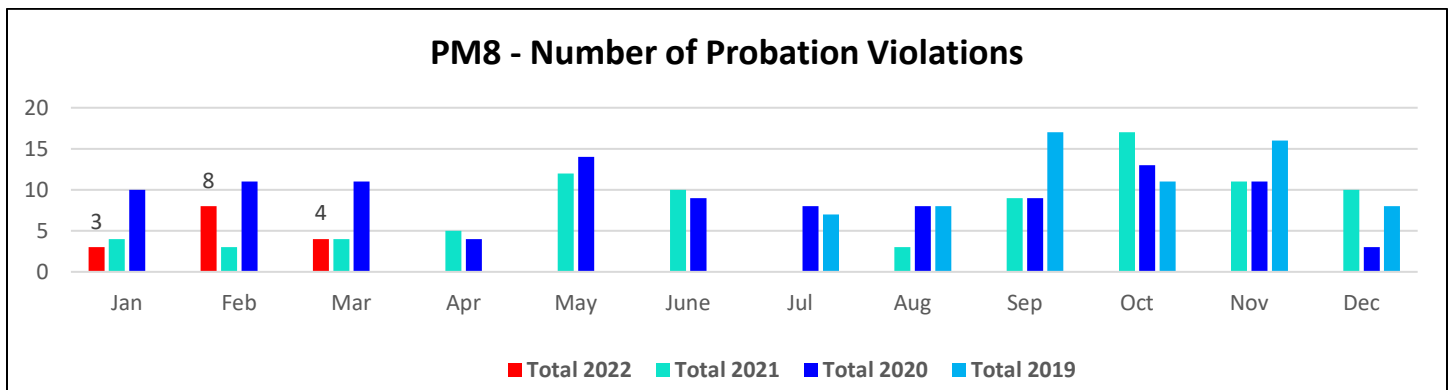


## PM7 – Average Days from Assignment to First Contact
