SUBJECT	Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from October 18, 2022, to December 13, 2022.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

#### Effective October 18, 2022:

• The Nurse Academy, Vocational Nursing Program – Requests Approved.

The Program requested to begin a Part-Time Vocational Nursing Program.

Additionally, the Program requested a part-time curriculum effective November 29, 2022. The proposed 78-week part-time curriculum consists of 594 theory hours and 960 clinical hours.

Additionally, the Program requested to admit a part-time evening/weekend class of 24 students to commence on November 29, 2022, with a graduation date of August 11, 2024.

#### Effective November 1, 2022:

# • Career Care Institute, Oxnard, Vocational Nursing Program – Request Approved.

The Program requested to admit a class of 40 students to commence on December 19, 2022.

### • Homestead Schools, Inc., Costa Mesa, Vocational Nursing Program – Requests Approved.

The Program requested initial approval for the four-year period beginning November 1, 2022, and issue the certificate accordingly.

Additionally, the Program requested to admit an initial class of 30 students in February 2023.

### • Moriah Medical College, Vocational Nursing Program – Request Approved.

The Program requested to admit a full-time class of 30 students to commence on November 28, 2022.

### • Medical Career College, Vocational Nursing Program – Request Approved.

The Program requested to admit a full-time class of 36 students to commence on February 20, 2023, with a graduation date of February 2, 2024.

### • Platt College, Alhambra, Vocational Nursing Program – Request Approved.

The Program requested to admit a full-time day class of 24 students to commence on March 27, 2023, with an expected graduation date of June 5, 2024. This cohort will replace the cohort which graduated on October 24, 2022.

## • Summit College, El Cajon, Vocational Nursing Program – Request Approved.

The Program requested to admit a full-time day class of 25 students to commence on December 5, 2022, with an expected graduation date of December 4, 2023. This class will replace the class which graduated on November 11, 2022.

#### Summit College, San Bernardino, Vocational Nursing Program – Request Approved.

The Program requested to admit a full-time day class of 40 students to commence on December 5, 2022, with an expected graduation date of December 1, 2023. This cohort will replace the cohort which will graduate on November 11, 2022.

### Effective November 29, 2022:

#### • Angeles Institute, Vocational Nursing Program – Request Approved.

The Program requested to admit a full-time class of 45 students to commence on January 2, 2023, with a graduation date of November 3, 2023, to replace students that graduated on November 4, 2022.

### • Gavilan College, Vocational Nursing Program – Requests Approved.

The Program requested to admit a full-time class of 30 students to commence on January 30, 2023, with a graduation date of May 30, 2024, to replace the class that graduated on May 27, 2022.

Additionally, the Program requested a pattern of admission to include one full-time day class every 18-months, alternating Spring and Fall, starting with the January 2023 class.

#### Grossmont Health Occupations Center, Vocational Nursing Program – Request Approved.

The Program requested a curriculum revision effective January 9, 2023. There is no change in the length of the Program. The proposed curriculum consists of 726 theory hours and 1012 clinical hours totaling 1738 hours.

#### • Gurnick Academy of Medical Arts, Concord, Psychiatric Technician Program – Requests Approved.

The Program requested to admit a full-time day class of 20 students commencing on January 3, 2023, graduating on January 26, 2024, to replace the class that graduates on January 27, 2023.

Additionally, the Program requested a curriculum revision of the full-time curriculum of 48 weeks effective January 3, 2023. The proposed curriculum consists of 616 theory hours and 954 clinical hours, totaling 1570 hours.

#### Gurnick Academy of Medical Arts, Sacramento, Vocational Nursing Program – Request Approved.

The Program requested to admit a class of 90 full-time students to commence on January 3, 2023, with a graduation date of January 26, 2024. Forty-five of these students will be in a day class and forty-five students will be in an evening class.

# Gurnick Academy of Medical Arts, San Mateo, Vocational Nursing Program Requests Approved.

The Program requested to admit a full-time day class of 30 students to commence on January 3, 2023, with an expected graduation date of January 26, 2024, to replace the class which will graduate on January 27, 2023.

Additionally, the Program requested to admit a full-time evening class of 30 students to commence on January 3, 2023, with an expected graduation date of January 26, 2024, to replace the class which will graduate on January 27, 2023.

Additionally, the Program requested a pattern of admission to include four full-time classes of 30 students per calendar year. The program will admit two classes in January, one day and one evening, and two classes in July, one day and one evening.

#### North-West College, Long Beach, Vocational Nursing Program – Request Approved.

The Program requested continued full approval a four-year period beginning November 30, 2022, and issue a certificate accordingly.

## • North-West College, Riverside, Vocational Nursing Program – Requests Approved.

The Program requested to admit a full-time evening class of 45 students to commence on January 17, 2023, with a graduation date of March 29, 2024, to replace the class graduating on January 13, 2023.

The Program requested to increase the class size from 30 to 45 students four times a year to start with the cohort on January 17, 2023.

## • North-West College, San Diego, Vocational Nursing Program – Requests Approved.

The Program requested initial approval for the four-year period beginning October 17, 2022, and issue the certificate accordingly.

Additionally, the Program requested to begin an initial full-time class of 45 students on November 30, 2022, only, and graduating February 19, 2024.

Additionally, the Program requested approval of a 60-week full-time curriculum, four 15-week terms of 1652 Program hours, including 698 theory hours and 954 clinical hours.

# • Quest Nursing Education Center, Vocational Nursing Program – Requests Approved.

The Program requested to admit a part-time day class of 30 students to commence on January 23, 2023, with a graduation date of March 31, 2024.

Additionally, the Program requested to admit a part-time evening class of 30 students to commence on January 23, 2023, with a graduation date of March 31, 2024.
