Agenda Item 1 Call to Order, Roll Call, and Establishment of Quorum.

The meeting was called to order by Board President, Tammy Endozo at 11:35 a.m., Tuesday, April 30, 2019. Board Members introduced themselves by announcing their name, location, and noting if public participants were present. Establishment of quorum was confirmed by a roll call vote.

Agenda Item 3 Introduction of Board Members and Board Staff/Chair's Remarks.

Elaine Yamaguchi, Executive Officer, introduced herself and staff present. Kenneth L. Swenson, DCA Senior Staff Counsel Attorney III, introduced himself.

Agenda Item 4 Review and Possible Action on Draft Regulatory Language for Implementation of AB 2138 (Chiu 2018).

Ms. Yamaguchi gave background of the agenda item. AB 2138 was approved last year and BVNPT must modify regulatory language to implement the bill. The bill pertains to licensees with a criminal history.

The Board members received a copy of the proposed regulatory language with revisions made by the Legislative and Regulations Committee on March 25, 2019.

Timothy Matsumoto presented the revised regulatory language necessary to implement AB2138. Department of Consumer Affairs recommends its Boards and Bureaus have regulatory language necessary to implement AB 2138 in place prior to July 1, 2020. He explained what the regulatory package must include to be submitted to the Office of Administrative Law. DCA's various Boards and Bureaus must develop criteria for determining whether a crime is substantially related to the qualifications, functions, or duties of the business or profession.
