Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from July 29, 2021 to October 19, 2021.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective July 29, 2021:

- **Advanced College, South Gate, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 20 students commencing on August 2, 2021, graduating on December 6, 2022, to replace the class that graduates on July 20, 2021.

- **Career Care Institute, Moreno Valley, Vocational Nursing Program – Request Approved.**

The Program requested to begin a full-time evening class of 25 students commencing on August 2, 2021, graduating on November 19, 2022. This is not a replacement class. This is an additional class.

- **Gurnick Academy of Medical Arts, Concord, Psychiatric Technician Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning May 3, 2021 and issue a certificate accordingly.

- **High Desert Medical College, Lancaster, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning August 24, 2021 and issue a certificate accordingly.

- **Angeles Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students commencing October 4, 2021, and graduating on August 5, 2022, to replace the class that graduates August 21, 2021.

Effective August 10, 2021:

- **Bakersfield College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning on May 13, 2021 and issue a certificate accordingly.

- **California Care Institute, Oxnard, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 40 students commencing on August 30, 2021, and graduating on December 18, 2022, to replace the class that graduated on May 26, 2021.

- **Nurses' Development Center, Inc., Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 30 students on October 25, 2021 with a graduation date of October 14, 2022.

Additionally, the Program requested a major curriculum change to the 48-week full-time program that includes 683 theory and 968 clinical hours, totaling 1651 hours.

Additionally, the Program requested to add a part-time 85-week curriculum to include 683 theory and 968 clinical hours, totaling 1651 hours.

- **Pasadena City College, Vocational Nursing Program – Requests Approved.**

The Program requested a curriculum revision that includes a 41-week full-time program to include 630 theory hours and 964 clinical hours. The total program hours are 1594 hours.

Additionally, the Program requested to admit a full-time day class of 20 students commencing on August 23, 2021, and graduating on July 15, 2022, to replace the class that graduates on August 12, 2021.

- **Summit College, San Bernardino (previously Colton), Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 20 students to commence on August 16, 2021, with a graduation date of August 12, 2022. This class will replace the class which graduated on August 6, 2021.

- **Unitek College, Bakersfield, Vocational Nursing Program – Request Approved.**

The Program requested to admit a class of 36 full-time day students to start on August 30, 2021, with an expected graduation date of August 12, 2022.

Effective August 24, 2021

- **Carrington College, San Jose, Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant continued approval for a four-year period, commencing on August 24, 2021, and issue a certificate accordingly.

Additionally, the Program requested a class of 20 students.

- **Platt College, Riverside, Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant them a new program for full approval for a four-year period, commencing on August 24, 2021, and issue a certificate accordingly.

Additionally, the Program requested a class of 20 students, and approval of a 120 week-curriculum, six 20-week terms, containing 1613 hours.

- **Smith Chason School of Nursing, Ontario, (formerly WCUI School of Nursing, Ontario), Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant continued approval for a four-year period, commencing on August 31, 2021, and issue a certificate accordingly.

Additionally, the Program requested a class of 30 students.

Effective September 7, 2021

- **Platt College, Alhambra, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued approval for a four-year period, commencing on August 25, 2021, and issue a certificate accordingly.

- **Los Angeles Job Corps Center, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 15 students commencing on September 20, 2021, with a graduation date of December 31, 2022.

Effective September 21, 2021

- **Angeles College, City of Industry, Vocational Nursing Program – Requests Approved.**

The Program requested a full-time revised curriculum consisting of 52 weeks, effective November 8, 2021. The proposed curriculum consists of 706 theory hours and 1094 clinical hours totaling 1800 hours.

Additionally, the Program requested: a part-time revised curriculum consisting of 72 weeks, effective September 27, 2021. The proposed curriculum consists of 706 theory hours and 1094 clinical hours totaling 1800 hours; a part-time class of 25 students commencing on September 27, 2021, graduating on March 26, 2022, this is an additional class; and a full-time class of 25 students commencing on November 8, 2021, and graduating on December 9, 2022, this class will replace the class which is scheduled to graduate on November 30, 2021.

- **Institute of Technology, Clovis, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students commencing November 8, 2021, and graduating on December 9, 2022, to replace the December 13, 2021 graduating class.

- **Institute of Technology, Modesto, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on November 8, 2021, with a graduation date of December 9, 2022, to replace the December 10, 2021 graduating class.

- **Marian College, Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on November 8, 2021, with a graduation date of February 22, 2023.

- **Merced College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period, beginning on November 14, 2021, and issue a certificate accordingly.

- **Unitek College, Concord, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued approval for a four-year period to start on August 8, 2021 and issue a certificate accordingly.

Effective October 5, 2021

- **Blake Austin College, Vocational Nursing Program – Request Approved.**

The Program requested to increase the number of students within the ongoing pattern of admission to two full-time evening classes of 40 students, and two full-time day classes of 40 students.

- **Career Care Institute Moreno Valley, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time evening class of 30 students commencing on November 8, 2021 and graduating on March 16, 2023. This class will replace the class which graduates on October 17, 2021.

- **Career Care Institute Oxnard, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time evening class of 40 students commencing on November 1, 2021, and graduating on March 5, 2023, to replace the class that will graduate on October 17, 2021.

- **Information of Technology, Redding, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning September 15, 2021 and issue a certificate accordingly.

- **Medical Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 36 students on November 8, 2021, to graduate on November 21, 2022, to replace the class that graduates October 6, 2021.

- **National Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on November 15, 2021, with a graduation date of March 6, 2023, to replace the November 15, 2021, graduating class.

- **Santa Barbara Community College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning November 16, 2021 and issue a certificate accordingly.

- **Stanbridge University, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a part-time class of 45 students to commence on November 16, 2021, with a graduation date of March 22, 2023, replacing the September 7, 2021, graduating class.

 - a. Five 46-week full time day classes of 36 students per year,
 - b. Two 75-week part-time evening class per year,
 - c. Not to exceed seven enrolled classes of students at one time.

- **California Career Institute, Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning October 18, 2021 and issue a certificate accordingly.

Additionally, the Program requested to admit a part-time evening class of 30 students to commence on October 26, 2021 with an expected graduation date of June 10, 2023, to replace the class that graduated on September 10, 2021.

- **Medical Allied Career College, Vocational Nursing Program – Request Approved.**
