Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from April 19, 2022, to June 28, 2022.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective April 19, 2022:

- **Allied Medical & Health Services, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 15 students to commence on July 21, 2022, with a graduation date of January 8, 2024, to replace the class graduating June 27, 2022.

- **California Career Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time evening class of 30 students to commence on May 2, 2022, with an expected graduation date of December 1, 2023, to replace the class that graduated on March 11, 2022.

- **California Nurses Educational Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit an additional full-time evening class to the pattern of admission of 30 students to commence on September 5, 2022, with a graduation date of September 30, 2023.

- **Grossmont Health Occupations Center, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval a four-year period beginning April 11, 2022 and issue a certificate accordingly.

- **Hacienda La Puente Adult Education, Psychiatric Technician Program – Request Approved.**

The Program requested to admit a full-time class of 10 students to commence on May 9, 2022, with a graduation date of June 7, 2023.

- **National Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class day class of 30 students to commence on April 25, 2022, with a graduation date of August 17, 2023, replacing the March 18, 2022, graduating class.

- **North Orange County Regional Occupational Program, Vocational Nursing Program – Request Approved.**

The Program requested approval of the Program's curriculum revision from a full-time curriculum of 48.5 weeks to a revised full-time curriculum of 49 weeks, effective September 26, 2022. The proposed curriculum consists of 591 theory hours and 954 clinical hours totaling 1545 hours.

- **North-West College, Long Beach (previously Glendale), Vocational Nursing Program – Request Approved.**
