Staffing

The Enforcement Division currently has an open Associate Governmental Program Analyst (AGPA) position, one open Staff Services Analyst (SSA) position and two open Program Technician III (PT III) positions

Statistical Overview

Attached is the BVNPT Enforcement Report - This report includes statistical data from 2018 to present.

Total Number of Pending Cases

The total number of pending investigations in the 2023FY, Quarter Two is 870.

Total Number of Investigations Completed

The total number of investigations completed in the 2023 FY, Quarter Two is 505.

The average number of days to complete investigations is 188 days, well within the target of 360 days.

Total Number of Cases Referred to the Attorney General’s Office

The total number of cases sent to the Attorney General’s office for formal discipline was 55 in the 2023 FY, Quarter Two.

Total Number of Disciplinary Cases Completed

The total number of disciplinary cases completed was 45 in the 2023 FY, Quarter Two.

Licensee's On Probation

During the in the 2023 FY, Quarter Two, there were 14 new probationers. The average number of days from assignment to first contact was 3 days. This is well within the target of 15 days.

Strategic Planning and Implementation

The Enforcement Division continues to diligently work towards closing cases. We are working with the Division of Investigations to take on more of our cases. We believe that this will allow us to close cases faster and create a budgetary savings. We will continue to work with the Enforcement Committee on efficiencies and cost savings strategies.

Licensee Reminder

BVNPT typically sees an increase in our licenses being arrested for driving while intoxicated during the holidays. Due to this, we sent a reminder to our licensees not to drive while intoxicated. We received positive feedback from those who were sent this reminder.

Licensed Vocational Nurses as Independent Contractors

The BVNPT Enforcement Division has recently received multiple complaints against Licensed Vocational Nurses (LVN's) performing services as independent contractors assigned by staffing agencies. Unlike the typical arrangement in which the LVN's are employees of the staffing agency, these LVN's are characterized by the staffing agency as independent contractors and accept assignments from a platform maintained and controlled by the staffing agency. A substantial legal question exists whether LVN's, who are not independent practitioners but must work under the supervision of a licensed physician or registered nurse under Business and Professions Code section 2859, can satisfy the legal conditions for independent contractor status under Labor Code section 2750.3. The BVNPT Enforcement Division is actively investigating these complaints and taking other appropriate steps to examine the issue of LVN's performing services as independent contractors.
