Jennifer Almanza, Staff Services Analyst, presented the Board Member Travel Guide.

Board Discussion:

- Eric Mah recommended that we take out the portion of the Board Member Travel Guide that references inconveniences in air travel brought about by the national tragedy of September 11, 2001.
- Andrew Moreno and Todd D'Braunstein thanked Ms. Almanza for her hard work in processing the Board Member's travel.
- Eduardo Angeles stated that there is no area on the Travel Expense Claim to explain parking in higher priced lots at the airport.

8. POLICIES AND PROCEDURES.

A. Consideration of Board Member Per Diem (Business and Professions Code Section 103).

Marilyn Kimble, Enforcement Division Chief

Public Comment: None received.

Board Discussion:

- Mr. Mah inquired whether other healing arts board have one day per diem per month.
- Samantha James-Perez stated that the time actually spent reviewing cases is over 16 hours.
- John Vertido pointed out that the decisions made by the Board affect licensees and schools. This increase is an attempt to recognize the actual work the Board is doing.
- Mr. Mah expressed concern that increasing the per diem may be perceived negatively.
- Vivien Avella stated that the Board Members should receive per diem for travel time.
- Donna Norton clarified that the Board Meeting is an official day of business.
- Mr. Mah stated that Board Members should receive per diem payment for two days in non-Board Meeting months and three days in Board Meeting months.

MOTION: Adopt staff's recommended changes as presented with Mr. Mah's amendment to specify two days per diem for non-board meeting months and three days per diem for board meeting months.

B. Consideration of Policy for Processing Proposed Program Applications.

Cheryl Anderson, Supervising Nursing Education Consultant

- Mr. Vertido asked how many curriculums are submitted with errors. Ms. Anderson responded that almost 100% are initially submitted with errors.
- Mr. Vertido asked if Directors of Nursing (DON) are replaced if owners of the approved schools are not pleased with the Directors' submission of information to the Board. Ms. Anderson responded that DONs are frequently replaced.
- Samantha James-Perez stated that the NEC's cannot spend time on programs that do not have a director or no longer interested in starting a school. Focus should be on proposed programs that have a Board approved director.
- Jessica Leavitt asked if the 145 pending proposed program applications include non-responsive schools. Ms. Anderson responded affirmatively.
- Ms. Leavitt stated that the moratorium is to let the proposed programs know the expectations on timeframe.
- Laura Freedman clarified that the moratorium would not stop the Board from accepting applications for new programs. It would enable the Board to delay consideration of these new applications.

MOTION: To accept the report and adopt the recommendations as follows:

1. Approve a moratorium on processing new proposals for commencement of vocational nursing and psychiatric technician programs through February 28, 2015;
2. Direct staff to remove the non-responsive proposed programs from the queue of programs to be analyzed and issue a notice to the non-responsive programs as described in Attachment B; and
3. Direct staff to advise proposed programs without a current Board-approved director that their proposals will not be processed until a director, approved by the Board, is in place and advise that if such action does not occur in 30 days that the proposed program will be removed from the queue of programs to be analyzed.

9. REVIEW OF 2014 STRATEGIC PLAN.

Teresa Bello-Jones, Executive Officer presented the 2014 Strategic Plan.

Public Comment: None received.

Board Discussion:

- Tricia Hunter, American Nurses Association, California, stated that the Board of Registered Nursing (BRN) has encountered numerous problems with the implementation of BreEZe. Particularly, renewals and endorsements have been a big issue. She recommended that the Board work with BRN staff to facilitate a smooth transition to BreEZe.

Additionally, Ms. Hunter recommended the Board consider raising the monetary amount of fines or bail for criminal convictions that must be reported from the current \$500 to \$1,000.

10. REVIEW OF 2014 BOARD GOALS.

Teresa Bello-Jones, Executive Officer, presented the 2014 Board Goals.

Public Comment: None received.

Board Discussion:

- Ms. Avella stated that she wants the Board to set specific goals. She indicated that the Board should have general guidelines on processing, such as the backlog of proposed programs. Mr. D'Braunstein responded that Ms. Anderson report from earlier in the meeting provides clarification of actions taken to address the backlog of proposed programs.
- Susan Rubin stated that some of the issues can be addressed with more data in the report.

11. BUDGET UPDATE.

Angelina Martin, Assistant Executive Officer, presented the Budget Update.

Public Comment: None received.

Board Discussion:

- Mr. Vertido asked Ms. Martin if a Budget Change Proposal (BCP) can be stopped at any level. Ms. Martin indicated that a BCP can be stopped at any level and that the BCP submitted for implementation of AB 1028 was stopped at the agency level due to the Board's vacancy rate.
- Mr. Mah requested a breakout of expenditures on the Budget sheet and updated data relative to BreEZe.
- Vivien Avella stated that the merging of VN and PT funds doesn't happen for a few years. She asked if this process has started. Ms. Martin indicated that legislation still needs to be developed and introduced to begin the process to merge the funds.
- Mr. Vertido stated that the Board decided to merge the funds to delay raising relevant fees to a maximum statutory limit. Mr. Vertido asked if the Board should also consider a proposal to raise fees. Ms. Bello-Jones stated that it is not likely that a fee increase would be approved at this time.
- Ms. Martin indicated that DCA representatives would be invited to present information about BreEZe costs and the Board's Budget at its next Board Meeting in May 2014.

12. LICENSING DIVISION UPDATE.

Carol Northrup, Licensing Program Manager, presented the Licensing Division Update.

Public Comment: None received.

Board Discussion:

- Mr. Vertido stated that it is his understanding that program pass rates typically decrease when the examination plan is changed. Ms. Anderson confirmed that the examination outline is the blueprint for development of the licensure examination. After implementation of a new examination outline, program pass rates initially decline. Subsequently, program pass rates increase.

13. ENFORCEMENT DIVISION UPDATE.

Marilyn Kimble, Enforcement Division Chief

Public Comment:

- Tricia Hunter, RN Board 1 vote for closed session. Thinks BMs deliberation is wonderful.

Board Discussion:

- Mr. Mah requested clarification on the mail ballot process. The current Board policy is that 2 or more votes for closed session results in the case going to closed session. He stated that having so many non-adopt options dilutes the chance of the case going to closed session.
- Ms. Avella asked if there are four votes to adopt and three to non-adopt, does it go to closed session. Ms. Freeman responded that the case would go to closed session.
- Mr. Mah recommends that the Board have two options; adopt or closed session.
- Mr. Vertido stated that the Board Members make decisions based on their own experiences. Having two options may force them to go a certain direction.
- Ms. Avella stated that Board Members have the right to non-adopt.
- Ms. Freedman stated that her clients in the past would go to closed session if there were at least two non-adopt or closed session votes.

- Ms. James-Perez stated that the current mail ballot is heavily weighted to adopt so it's difficult to get a non-adopt vote.
- Ms. Avella stated that she doesn't believe that 2 votes for non-adopt or closed session should sway 9 votes to adopt.

14. EDUCATION DIVISION UPDATE.

Board Discussion:

- Mr. D'Braunstein asked if the charts in the report are consistent with the schools on provisional approval. Ms. Anderson responded yes. All programs on provisional approval are private institutions. Ms. D'Braunstein asked if the schools on provisional approval cause more workload, and if so, can we determine the amount of extra work hours it causes. Ms. Anderson stated that this is data that we can obtain.

- Vivian Avella requested that the Board set tangible goals for processing the approved school applications and include the workload status in future Executive Officer’s reports.
- Andrew Moreno asked the Board staff if the Senate gave any inclination on what the outcome of the Joint Informational Hearing would be. Ms. Bello-Jones responded that there is not any current legislation, but that a spot bill is a possibility.

- Jay Prouty, Enforcement Program Analyst, stated that there is an error in the Disciplinary Board Meeting Minutes. The Board Member’s decision regarding Heather Zander’s Petition for Early Termination of Probation should state, “The Board denied the Petition for Early Termination of Probation of the vocational nurse license, but granted a modification of the conditions of probation.”

9. PRESENTATION OF 2013 ANNUAL REPORT

Teresa Bello-Jones, Executive Officer, presented the 2013 Annual Report with the following highlights:

- The Board continued its development of the Investigations Unit within the Enforcement Division.
- The Board continued to assist in the development, configuration and design of the BreEZe system to meet the Board’s business requirements and processes.
- Legislative and Regulatory actions.
- Statistical data and workload activities.
- Liaison activities.

Public Comment: None received.

Board Discussion: None received.

10. BreEZe UPDATE

Mark Ito, Licensing Analyst, provided an update to the status of the implementation of BreEZe, which will replace the existing Consumer Affairs System (CAS), Applicant Tracking System (ATS), and multiple workaround systems with a commercial off-the-shelf system for use by the DCA organizations.

Public Comment: None received.

Board Discussion:

- Andrew Moreno stated that he is aware of issues with BreEZe for the Board of Registered Nursing and inquired if the Board is aware of issues with other Boards. Mr. Ito responded that there have been issues for the Boards and Bureaus included in the first release of BreEZe. However, the Board is ensuring that all processes are provided to the BreEZe Team at a granular level and that the lessons learned from the first release of BreEZe will assist the Board in the development of our system.
- John Vertido asked Mr. Ito if there is a backup option in place for BreEZe if the system cannot manage the Board's business processes efficiently. His concern is that the Board encourages students to take the examination shortly after they graduate, but the system may not be able to approve them to take the examination in a timely manner. Mr. D'Braunstein responded that the Board's backlog on school application has been resolved. Additionally, Mr. D'Braunstein stated that the BreEZe system will not be implemented until all of the Boards and Bureaus are in agreement that the system meets their business needs. Ms. Bello Jones stated that the CAS and ATS computer systems will be available for staff.

11. PRESENTATION OF THE LEGISLATIVE REPORT

Mark Ito, Licensing Program Analyst, reported on 12 bills currently being tracked.

Public Comment: None received.

Board Discussion: None received.

12.A. UPDATE ON PROPOSED REGULATORY ACTION TO IMPLEMENT AB 1588, WAIVER OF RENEWAL REQUIREMENTS

Mark Ito, Licensing Program Analyst, presented a report relative to proposed regulatory action to implement AB 1588, waiver of renewal requirements. AB 1588 requires the Board to waive the license renewal requirements for any licensee who is called to active duty as a member of the United States Armed Forces or the California National Guard. The Board anticipates filing a Notice of Proposed Regulations with the Office of Administrative Law in March 2014.

Public Comment: None received.

Board Discussion:

- John Vertido asked Mr. Ito if subsection (d) of the language refers to licensees on active duty working in their military capacity as a nurse. He is concerned that there may be a conflict of interest between the federal and state.

- Donna Norton requested the Board to clarify the language regarding active duty in the proposed language. She stated that the intent of the regulation is clear, but the language is vague.
- Laura Freedman stated that she will work with the Board on the proposed language.

12.B. UPDATE ON PROPOSED REGULATORY ACTION TO IMPLEMENT SB 539, PERMISSIVE SITE VISITS.

Mark Ito, Licensing Program Analyst, presented a report relative to proposed regulatory action to implement SB 539, permissive site visits. Mr. Ito reported that a public hearing was held on August 5, 2013. The Board received no oral or written comments from the public. Subsequently, on August 19, 2013, the Board published a 15-day notice of proposed changes as advised by the Board’s Legal Counsel. The notice specified changes recommended by the DCA Division of Legislative & Policy Review. On October 21, 2013, the Board approved the amended notice, proposed language, and Initial Statement of Reasons. Subsequently, DCA returned the Economic and Fiscal Impact Statement to the Board for correction. Preparation and submission of the Final Rulemaking File is anticipated to be completed in March 2014.

13. EDUCATION DIVISION REPORTS REGARDING VN & PT PROGRAMS

13.A.1. Medical Career College Vocational Nursing Program – Reconsideration of Provisional Approval; Consideration of Request to Admit Students.

Suellen Clayworth, Nursing Education Consultant (NEC), presented a report relative to reconsideration of provisional approval and consideration of the request to admit students for the Medical Career College, Fremont, Vocational Nursing Program. On February 18, 2010, the Board placed the program on provisional approval for the two-year period from February 18, 2010 through February 17, 2012, due to noncompliance with regulatory requirements relative to program pass rates. On February 24, 2012, the Board extended the program’s provisional approval for the one-year period from February 18, 2012 through February 28, 2013. On February 6, 2013, the Board extended the program’s provisional approval for the one-year period from February 22, 2013 through February 28, 2014.

Based on data from the 4th quarter of 2013, the program’s average annual pass rate is 69%, which is seven (7) percentage points below the state average annual pass rate.

Program Representative:

Marilyn Castillo, Program Director

- Ms. Castillo thanked Cheryl Anderson for her continued support. She indicated that one of the students who took the licensure examination during the last quarter of 2013 was a student who graduated over a year ago.

Public Comment: None received.

Board Discussion:

- Vivien Avella asked Ms. Castillo when the most recent class graduated. Ms. Castillo responded that the 13 students graduated in September 2013. Ms. Avella stated that the Board should be more consistent on the decisions made regarding schools on provisional approval.
- Eduardo Angeles asked Ms. Castillo if she supported the recommendations in the program's report. Ms. Castillo confirmed that she is in support of the recommendations.
- John Vertido stated that the student that graduated over a year ago is still one of her school's candidates regardless of the time elapsed after the graduation date.

MOTION: To accept the report and adopt the recommendation as follows:

1. Extend the Medical Career College Vocational Nursing Program's provisional approval for the one-year period from February 28, 2014 through February 28, 2015, and issue a notice identifying specific areas of non - compliance and requirements for correction as referenced in Section 2526.1 (e) of the California Code of Regulations (See Attachment D)
2. Approve the program's request to admit 15 students into a day class commencing August 11, 2014, and graduating September 4, 2015, to **replace** students scheduled to graduate June 6, 2014.
3. Approve the program's request to admit 15 students into an evening class commencing October 13, 2014, and graduating November 5, 2015, to **replace** students scheduled to graduate on October 9, 2014.
4. Require the program to admit no additional students unless approved by the full Board.
5. Require the program to submit a follow-up report no later than **November 1, 2014**. The report must include a review of the comprehensive analysis submitted by the program including the effect of employed interventions and identification of revisions required to the program's plan of correction, and a timeline for implementation.
6. Failure to show progress shall constitute cause for revocation of provisional approval.
7. Require the program to bring its average annual pass rate to no more than ten (10) percentage points below the State average annual pass rate.
8. Require the program to comply with all approval standards in Article 4 of the Vocational Nursing Practice Act, commencing at Business and Professions Code Section 2880, and Article 5 of the Board's Regulations, commencing at California Code of Regulations, Title 16, Section 2526.
9. Require the program to demonstrate incremental progress in correcting the violations. If the program fails to satisfactorily demonstrate incremental progress, the full Board may revoke the program's approval.
10. Failure to take any of these corrective actions may cause the full Board to revoke the program's approval.
11. Place the program on the **February 2015** Board agenda for reconsideration of provisional approval.

13.A.2. Valley College of Medical Careers Vocational Nursing Program – Reconsideration of Provisional Approval; Consideration of Request to Admit Students

Pam Hinckley, NEC, presented a report relative to reconsideration of provisional approval and consideration of the request to admit students for the Valley College of Medical Careers Vocational Nursing Program. On November 10, 2011, the Board placed the program on

provisional approval for the two-year period from November 10, 2011 through November 30, 2013, due to noncompliance with regulatory requirements relative to program pass rates. On November 22, 2013, the Board extended the program's provisional approval for the period from December 1, 2013 through February 28, 2014.

Based on data from the 4th quarter of 2013, the program's average annual pass rate is 69%, which is seven percentage points below the state average annual pass rate.

MOTION: To accept the report and adopt the recommendations as follows:

1. Extend provisional approval of Valley College of Medical Careers Vocational Nursing Program for the one (1) year period from February 28, 2014 through February 28, 2015 and issue a notice identifying specific areas of non-compliance and requirements for correction as referenced in Section 2526.1 (e) of the California Code of Regulations.
2. Require the program to bring its average annual pass rate to no more than ten (10) percentage points below the State average annual pass rate.

13.B.1. Career Colleges of America, Los Angeles, Vocational Nursing Program – Consideration of Inadequate Program Resources

Pam Hinckley, NEC, presented a report relative to the consideration of inadequate program resources for the Career Colleges of America, Los Angeles, Vocational Nursing Program. On November 14, 2013, the Board received electronic correspondence from Ron Schaechter, Chief Executive Officer (CEO) of the program, indicating that the school has stopped offering the vocational nursing program. On January 10, 2014, Mr. Schaechter emailed the Board and requested information on what the program would need to do should they decide to offer the vocational nursing program in the future. The Board advised Mr. Schaechter the program would need to get a Board-approved director and the director would need to complete and submit the program records survey which was due on June 3, 2013, and verify adequate staff and clinical facilities.

On January 28, 2014, the Board received information stating that Career Colleges of America, San Bernardino, South Gate, and Los Angeles, had ceased offering all classes at all campuses. Research into the status of the program substantiated that the Accrediting Council for Continuing Education and Training (ACCET) had withdrawn accreditation of all Career Colleges of America campuses effective January 9, 2014. The Bureau for Private Postsecondary Education (Bureau) confirmed that Career Colleges of America, Los Angeles, was approved by the Bureau by means of accreditation. Therefore, once the program lost their accreditation by ACCET, they also lost Bureau approval to operate.

Based on data from the 4th quarter of 2013, the program's average annual pass rate is 67%, which is nine (9) percentage points below the state average annual pass rate.

Program Representative: There was no program representative present.

Public Comment: None received.

Board Discussion:

- Ms. James-Perez asked if placing the program on provisional approval is necessary since their accreditation from the Accrediting Council for Continuing Education and Training (ACCET) has been taken away. Ms. Freedman stated that BPPE approval is a required condition for any private postsecondary program to operate in state, however BPPE does not require Board approval to operate.
- Ms. Norton asked the Board why Board staff is recommending provisional approval based on the school's history. Ms. Anderson stated that, to date, the Board has not given the school an official notice of identified deficiencies and required corrections. Pursuant to California Business and Professions Code Section 2883, the Board is required to issue the program an official written notice specifying identified deficiencies and required corrections. If the program fails to correct the deficiencies within a reasonable time, the Board may remove the program from its list of approved programs. Ms. Anderson stated that the recommendations will provide the school with the required official notice. The

program will be placed on the May 2014 agenda at which time the Board can reconsider the program's status and take final action.

In January 2014, the Board was informed of action taken by the Accrediting Council for Continuing Education (ACCET) at its December 2013 Commission Meeting. Due to the program's ongoing poor graduate job placement rates, the commission limited the program to admit no more than 120 students between December 23, 2013, and the April Commission Meeting. At the April 2014 meeting, the Commission is scheduled to review the status of the vocational nursing program and decide whether to continue approval of the program.

While researching that information and analyzing its relevance to current Board decisions, staff discovered that the Summit Career College, Colton, Vocational Nursing Program had admitted eighteen (18) classes without prior approval as required by the Board.

- Ms. Sheehan apologized to the Board and NECs.

Ms. Nacio stated that the program understands the gravity of the situation and the investigation shows that there was a miscommunication between the program and the Board.

13.E.1. CET - Nursing, Formerly Center of Education and Technology, Vocational Nursing Program – Reconsideration of Revocation; Consideration of Request to Admit Students

Pam Hinckley, NEC, presented a report relative to reconsideration of revocation and consideration of request to admit students for the CET – Nursing. On October 21, 2013, the Board revoked the provisional approval of the program, due to noncompliance with regulatory requirements relative to program pass rates.

Program Representative:

Ronaldo Verian, Program Director; Angie Suh, Owner

- Mr. Verian thanked the Board for their support and concurs with Ms. Hinckley's report. He stated that the latest licensure examination data places them in compliance with the Rules and Regulations. He indicated that this pass rate was achieved due to the school not requesting additional students. He stated that his program has been prudent in their actions to not request additional students. He asked the Board Members to consider reinstating their program.
- Ms. Suh stated that the application process was 3-4 months so the program's students were not able to take the examination in time for their pass rates to be reflected in the report.

Public Comment: None received.

Board Discussion:

- Ms. James-Perez asked Mr. Verian how long the program was on provisional approval. Mr. Verian responded that the program was on provisional approval for three years.
- Ms. Avella stated that the program had a class of 13 graduates in May 2013. Mr. Verian stated that 6 out of 7 examination candidates from that class passed the licensure examination. He also stated that he is actively reviewing all of the programs past classes. Ms. Avella asked Mr. Verian if he knows which class the recent examinees were from. Ms. Suh responded that the recent examinees are from the May 2013 graduating class.
- Ms. Avella stated that there is not enough data to overturn the Board's prior decision, but is it possible to reconsider the program at a later date. Ms. Freedman responded that she doesn't recommend it because the Board needs finality to these type of situations.
- Mr. Vertido stated that the program pass rates have been consistently low due to 18 of the past 21 quarters being below the State average annual pass rate. He also stated that the program has good intentions but the pass rates are not good enough.
- Ms. Avella stated that the Board should pay closer attention to the pass rates of pre-probation and post probation classes.
