SUBJECT	Education Division Report

COVID-19 Pandemic

Our school site visits continue to be on hold and will resume once the Department of Consumer Affairs (DCA) clear staff for travel. The Nursing Education Consultants (NECs) have been in regular contact with all their schools to ensure that learning is provided to the students at the optimal level possible during the pandemic.

The NECs report that the schools are all expressing serious concerns about the lack of clinical sites to provide hands on learning for the students. Many programs are using simulation, sometime 100 percent.

We have received many complaints from students about programs not following CDC guidelines and the lack of live clinical experiences; yet these programs continue to remain open without offering students any alternatives. Many are trying to get by using 100 percent simulation without Board approval or a dialogue with their NEC. A few of the Programs have been asked repeatedly for information by their NEC and they are either not providing it or the NEC must ask several times or ask the SNEC or EO to intervene on their behalf. This makes the NEC's job frustrating and when they do not have the requested documentation from the programs, they cannot do their jobs and assist the programs and students. Students are reporting that they are not provided the required hours or curriculum content, in any form, via simulation, as specified and approved by the program's Board-approved instructional plan.

Additionally we received a complaint from a program director who was concerned about the financial exploitation of students, inadequate resources and "providing 100 percent clinical simulation to the students in violation of the 50 percent approved by the Board so they can continue to draw funds without hands on experience."

Programs continue to be challenged by the pandemic. Clinical sites are scarce and even non-existent. We receive requests daily to allow 100 percent simulation for students because programs do not have clinical placement. We oppose 100 percent simulation as this provides no hands-on patient care. Simulation has a place in education, as an augmentation to hands on experiences, however there are clinical situations that cannot be simulated. Learning a psychomotor skill via role playing on a classmate can teach self-efficacy and fine motor dexterity. They will know what to expect as the student performs a nursing skill, thereby moving or responding in a manner that could be considered expected or predicated. An actual patient may not respond or move in a certain manner that could be considered expected or predictable. An actual/live/non simulated patient may not respond or move in an expected manner. It is hard to mimic a patient with dementia who is fighting you or simulate pain in a roleplay/simulated environment. Assessing skin conditions in the elderly are not the same as assessing a 25-year-old fellow student. Aspects of cultural diversity cannot always be mimicked and in California, nurses must be trained and able to work with culturallyspecific issues.

Issues and challenges in the pandemic:

- Lack of clinical sites for students.
- Lack of or insufficient PPE for all students.
- Difficulty transitioning to online format due to students' lack of computer skills, lack of access to a home computer or insufficient internet bandwidth.
- Lack of training and support for faculty to teach online.
- Concerns by faculty in maintaining online integrity.
- Students fear of contacting COVID-19 if they are allowed back into the clinical sites.
- Household disruptions with child care, family and work obligation while trying to complete online program requirements for both students and faculty.
- Dissatisfaction of students and faculty in an online learning environment versus in person.
- Students reporting lack of consistent or any communication from programs regarding the pandemic plans.
- Delays with program completion and the financial implications.
- Student concerns regarding adequate hands-on patient care to be a safe and competent entry level nurse/practitioner.
- Resistance by programs to recommendation to limit simulation to 50 percent of clinical hours
- Requests from programs for approval to offer students 100 percent simulation, with no hands-on patient care through the entire program.

The NEC's spend up to 80 percent of their day fielding questions and concerns like the ones listed above from programs, students and stakeholders. This creates a backlog in relationship to curriculum reviews/approvals, routine Board reports, review of

documents submitted by proposed programs and analysis of faculty and facility applications.

Revised Reporting Format

To make our NEC reports clear and transparent we are using a new format. The reports included in your packet reflect the new formatting.

An offer of employment has been made to replace Margarita Valdes. We are working out the employment details, and she will join the team next month.

Status of California Testing Sites

As of Monday, August 10, 2020, all 27 Pearson VUE Testing Centers are open with limited number of test dates per month. As Pearson VUE makes additional hires and adds days and hours, it is anticipated that they will be able to accommodate a greater number of candidates who need to test.
