SUBJECT Enforcement Division Report

STAFFING

Hired a new special investigator, Pooja Mohan, who had previously worked as an Associate Governmental Program Analyst (AGPA) in Enforcement. Currently working to hire a new AGPA.

The Enforcement Division re-directed an AGPA and an SSA to perform duties related to COVID-19 contact tracing, a multi-step process that involves interviewing individuals who test positive, identifying and locating their known contacts, and monitoring and supporting those who must self-isolate. Contact tracers work under the direction of the local health department and the California Department of Public Health and the assignment is expected to last approximately six to nine months.

STATISTICAL OVERVIEW

Attached is the BVNPT Quarterly Enforcement Report - This report includes statistical data from fiscal year 2019/20, quarter three, April 1, 2020 through June 30, 2020.

NOTABLE HIGHLIGHTS

Total Number of Investigations Assigned

During quarter four, the total number of cases assigned for investigation decreased from 552 to 395. This is a decrease of 157 cases over the previous quarter.

Total Number of Pending Cases

During quarter four, the total number of pending investigation cases decreased from 1,403 to 1,219. The total average pending age of all pending investigation cases increased from 267 days to 286 days.

Total Number of Investigations Completed

During quarter four, the total number of investigations completed increased from 517 to 566. The average number of days to complete investigations increased from 218 days to 249 days.

Of the 566 investigations completed, 73 percent were completed within the Board's enforcement performance measure (PM 3) target average of 360 days.

Total Number of Cases Referred to the Attorney General's Office

During quarter four, 48 cases were referred to the Attorney General's Office for formal disciplinary action.

Total Number of Disciplinary Cases Competed

During quarter four, 48 disciplinary actions were completed. The average number of days to complete these actions was 709 days. This is an improvement from the quarter three average of 749 days


Current Fiscal Year 2019/20 statistics by Quarter July 2019 through June 2020





















Quarterly statistics Fiscal 2016/17 through Fiscal 2018/19






















Comparison of monthly statistics based on calendar year, January 2018 through June 2020
