SUBJECT Enforcement Division Report

STAFFING

The Enforcement Division re-directed an AGPA and an SSA to perform duties related to COVID-19 contact tracing, a multi-step process that involves interviewing individuals who test positive, identifying and locating their known contacts, and monitoring and supporting those who must self-isolate. Contact tracers work under the direction of the local health department and the California Department of Public Health. The assignment is extended, and we do not expect staff to return until July 2021.

A staff member in LACRU recently promoted to a position at the Medical Board, and we are working to fill her position.

STATISTICAL OVERVIEW

Attached is the BVPT Quarterly Enforcement Report - This report includes statistical data from January 2021 to March 2021.

NOTABLE HIGHLIGHTS

Total Number of Investigations Assigned

During quarter three, the total number of cases assigned for investigation increased from 365 to 368. This is an increase of three cases.

Total Number of Pending Cases

During quarter three, the total number of pending investigation cases decreased from 1,111 to 1,073. The total average pending age of all pending investigation cases decreased from 290 days to 277 days.

Total Number of Investigations Completed

During quarter three, the total number of investigations completed increased from 442 to 468. The average number of days to complete investigations increased from 230 days to 268 days. This is in part, due to COVID-19. The other governmental agencies, private institutions, and courts we rely on to provide documentation slowed their response times. As we continue to work through the pandemic, we may see more instances of overall case aging, or lowered case closure rates for cases that require a judge to agree to the plea deal or a jury trial completed.

Of the 468 investigations completed, 70 percent were completed within the Board's enforcement performance measure (PM 3) target average of 365 days.

Total Number of Cases Referred to the Attorney General's Office

During quarter three, 53 cases were referred to the Attorney General's Office for formal disciplinary action.

Total Number of Disciplinary Cases Competed

During quarter three, 38 disciplinary actions were completed. The average number of days to complete these actions was 934 days, which is a decrease from the previous quarter's 935 days.

Licensee Probation

During quarter three, there were 18 new probationers. The average number of days from assignment to first contact was 10 days. The average days from a violation reported to action initiated was eight days.

Possible Issues Due to COVID-19

While the Enforcement Division is diligently working to close cases, we may continue to see case aging issues if the courts do not re-open fully or continue to maintain a sizeable backlog. Since Enforcement relies on local and federal courts for our criminal cases, delays may occur as we have no control over how the courts set their hearing calendars.

Furthermore, our complaint intake is down. This may be due to fewer issues occurring; however, it is more likely that the medical facilities are simply overwhelmed and not reporting in a timely manner. We expect to see a surge in reporting once the pandemic eases.

Petitioner Hearings Update

All the petitioner hearings have been sent to the Office of Administrative Hearings (OAH) and are being set for hearing. This completely cleared the petitioner backlog. The Enforcement Committee reviewed this issue, which will be reported on during the Enforcement Committee report by the Enforcement Committee Chair Ken Maxey.
