

SUBJECT	Education Division Report

COVID-19 Pandemic

The Nursing Education Consultants (NEC's) are back on the road conducting much needed site visits. Only the fully vaccinated NEC's are making visits.

Programs continue to be challenged by the COVID-19 pandemic. Some programs can return to clinical sites, while others express concerns about the lack of clinical sites to provide hands on learning for students. The NECs continue to receive temporary clinical/skills virtual online and live laboratory simulation plans from program directors for approval to accomplish the program's clinical/skills objectives.

Issues and Challenges During the Pandemic:

- Lack of clinical sites for students
- Lack of or insufficient PPE for all students
- Difficulty transitioning to an online format due to students' lack of computer skills, lack of access to a home computer or insufficient internet bandwidth
- Lack of training and support for faculty to teach online
- Concerns by faculty in maintaining online integrity
- Students fear of contacting COVID-19 if they are allowed back into the clinical sites
- Household disruptions with childcare, family and work obligations while trying to complete online program requirements for both students and faculty
- Dissatisfaction of students and faculty in an online learning environment versus in person

- Students reporting lack of consistent or any communication from programs regarding the pandemic plans
- Delays with program completion and the financial implications
- Requests from programs for approval to offer students up to 100 percent simulation, with little or no hands-on patient care throughout the entire program

The NECs spend up to 80 percent of their day reviewing clinical simulation plans and fielding questions and concerns from program directors, instructors, students, and stakeholders. This creates a backlog in relationship to curriculum reviews/approvals, routine Board reports, review of documents submitted by approved and proposed programs and analysis of faculty and facility applications.

Proposed Program Backlog

We developed and implemented a plan to clear this backlog. There were 60 programs on the list with 11 assigned to NECs on May 3rd. All the programs have been vetted to assess readiness to be assigned to an NEC, edited and changed any contact information and inquired as to their continued interest in pursuing a new program.

Staff Updates

Retired Annuitant, Timothy Matsumoto retired on Friday, March 26th. We wish Tim all the best in his second retirement from state service.

Staff Training

On March 11 the NECs attended the National Council of State Boards of Nursing's (NCSBN) virtual Education Day.

Directors Forum

The Directors' Forum on March 2 and March 3 via WebEx was a success, and . 108 program directors attended. Eighty eight percent of the attendees found the content to be extremely helpful and relevant. The majority preferred the online format while a small percent preferred the in-person format. The program directors provided many future topic suggestions for our next forum.

Nursing Simulation Information Forum

On February 17, we conducted a forum to introduce the various types of simulation available. Vendors and program directors provided an overview of simulation and how it is being implemented.

<u>Updating Forms</u>
The NEC's are close to finishing updating all Education Division forms, policies and procedures, prior to converting them to Americans with Disabilities Act (ADA) format. The forms will also be made PDF-fillable as a courtesy to the programs.
