**SUBJECT** Licensing Division Report

#### **STAFFING UPDATE:**

Since the last Board Meeting, all vacant Licensing Division positions have been filled.

Due to the ongoing COVID-19 pandemic, approximately fifty percent of Licensing Division staff continue to telework and were on-site only to drop-off and pick-up files and correspondence. On-site staff continue to provide cashiering and front counter service. Staff observe safety practices such as social distancing, hand washing, and the use of hand sanitizer and Clorox wipes. Gloves are available, especially when handling cash/cards. Licensing staff continue doing an outstanding job during these unprecedented times.

#### **VERIFICATION PROJECT:**

Since the pandemic began, we noticed an increased number of calls and emails from California LVNs applying for licensure in other states stating that the nursing regulatory bodies they're applying to were not receiving their California license verifications. We discovered that due to the pandemic, many nursing regulatory bodies were solely teleworking, delaying their ability to receive verifications via postal mail. Licensing Supervisor Ivan Brent along with Licensing Technician Sarah Long began contacting nursing regulatory bodies in the United States and in just over a month were able to reach agreements with forty-two nursing regulatory bodies to accept verifications via email. Prior to this project, only five nursing regulatory bodies had agreed to accept electronic verifications from our Board. The ability for Licensing Division staff to electronically send license verifications directly to the appropriate processing unit within each nursing regulatory body improved processing time, cut down on inquiry calls and emails, and saves the Board money. We receive, on average, 1,971 license verification requests per year. This saves the Board an average of \$1,000 per year in postage costs, not including paper, envelopes, and ink.

#### LICENSING STATICS:

The Licensing Division Statistical Data – Executive Summary is included with the Board materials. These comprehensive Licensing statistics cover activity from January 1, 2018 through March 31, 2021.

There was a significant increase in out-of-state LVNs applying to California by endorsement during January 2021 through March 2021. We received, on average, ninety-nine endorsement applications per month during this time, whereas, during the same time a year ago we received, on average, forty-two endorsement applications per month, for a 135 percent increase. We also had a 36 percent increase in verification requests received during January 2021 through March 2021 compared to the same time last year.

The Licensing Technicians are doing an amazing job on the inquiry phone line. January 2021 through March 2021, we had an average 91percent caller assist rate, up from an average 78 percent caller assist rate during this time last year. Our average caller wait time decreased to 3.4 minutes during January 2021 through March 2021 from 8.75 minutes during this time last year.

Public counter traffic continued to remain low with an average of fifty-three visitors for February and March, whereas during the same time one year ago we received, on average, 171 visitors a month to the public counter. On a side note, the public counter was closed effective December 7, 2020, through January 25, 2021, in response to the most recent Stay at Home Order, in which, effective December 7, 2020, the California Department of Human Resources directed all state offices to be closed to the public.

#### **CE AUDIT UPDATE:**

CE audits continue to be suspended due to COVID-19 and the Governor's Executive Order N-39-20 which included a temporary waiver of the continuing education requirement for individuals whose active licenses expired between March 31, 2020, and May 29, 2020, and extended to include licenses that expire between May 30, 2020, and May 31, 2021. We will reevaluate CE audits on June 1, 2021, and, depending on the situation, may extend the suspension.
