SUBJECT	Agenda Item 11: Board Member Ballot Voting		

Following a discussion with the Executive Committee and Counsel, we would like to provide Board Members with some clarifying information about the processing and tabulation of the ballot voting.

## The Vote Log

Case voting is a vitally important part of a board member's responsibility. We must have at least six Board members to vote to process the case.

The first attachment is the 2021 Vote Log. The Enforcement staff sends out packets approximately twice a month, and processes the returned ballots, and arranges for closed session discussions as needed. This is reflected in this table.

Staff sometimes sends the board members individual cases for review, when action is needed before the next scheduled packet. These individual votes are not included in this table.

Since early 2019, the Vote Log has been shared with the Executive Committee, along with updates on mandatory training, paperwork, and attendance. The Executive Committee provides a critical oversight function in Board management by keeping abreast of compliance and engagement, and when needed, they have approached individual members to encourage them to vote and/or comply with other requirements.

This information is not uploaded to our web page, nor is it generally included in the regular full agenda packets to the whole board. The issue arose last month, when the entire Board was invited and encouraged to attend the Executive Committee meeting, to be able to participate in any discussions about our Sunset legislation.

# **Open Meetings**

All of our board and committee meetings are open meetings, and we have had guests in attendance. But because we have not had more than two Board members attending before, except for the Education and Practice Committee, we have not been subject to the Bagley-Keene requirements for advance posting of agendas and materials. It is an internal goal to work toward this increased transparency.

At the May meeting, the Board directed staff to ensure that the next Executive Committee meetings were publicly noticed and agendized so that Board members could participate in updates and discussion about our Sunset Legislation, the Initial Program Approval processes, and the school program fee structure proposal.

This meant that the entire Board was sent the July Executive Committee meeting agenda, with this report. As most of the members have never seen this report, it's understandable that it was surprising and confusing.

### The Bottom Line

Board members are public officials, and this information is all available upon request. It is reported in our Sunset Report (see the sample page, attached), and provided to the Legislature, appointing authorities, the Department and our parent Agency. We seek to be completely transparent, but this board has had experience with disgruntled individuals who choose to "troll" for information about our members and send harassing emails, and chose not to post this information for the sake of posting.

The staff and I hope that this helps clarify this issue, and we are happy to provide any additional information or background. In addition, we plan to provide training and discussion at the November 2021 Board Meeting.

Appointed by Governor Edmund G. Brown, Jr. on May 5, 2015.

She is the Founding Chair of the William V. S. Tubman University (Harper, Liberia) Foundation Board and an active member of Alpha Kappa Alpha Sorority, Incorporated (the oldest African American Sorority in the world with a commitment of service to all mankind). Dr. Bass de Martinez holds a bachelor's degree in Spanish and Chemistry, a master's degree in education from the University of Northern Colorado and a Ph.D. from the University of Florida in curriculum and instruction. In 2016, she was awarded an Honorary Doctorate Degree, Honoris causa by William VS Tubman University (Harper, Maryland County, Liberia) for exemplary services in social development and outstanding commitment to humanity across the globe.
