Reaffirm that implementation of the pilot program and/or any other processes for improving the program approval process is contingent upon statutory authority to assess fees for the work that the Board provides to the educational programs and recognize that if the legislature is not inclined to approve the fees, the Board must move forward with a new program approval process that is vetted through the Board and stakeholders; and

4. Direct staff to take those actions reasonably necessary to develop bill language to effectuate the Program Concepts, to study the potential effects of any proposed bill language, and to assess its fiscal and budgetary impact through consultation with the Department's Budget Office to include consultation on the potential need for a third party fee study on the proposed school fees.
