Subject: **Approval and Ratification of Executive Officer Review Decisions and Report of Board Nursing Education Consultant Program Reports from January 11, 2022 to March 22, 2022.**

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs) at Executive Officer Reviews. These decisions now come before the Board for approval and ratification.

Effective January 11, 2022:

- **American Career College, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested the Board approve the Program's curriculum revision from a full-time curriculum of 54 weeks to a revised full-time curriculum of 55 weeks, effective January 22, 2022. The proposed curriculum consists of 675 theory hours and 955 clinical hours, totaling 1630 hours.

Additionally, the Program requested the Board approve the Program's curriculum revision from a part-time curriculum of 84 weeks to a revised part-time curriculum of 85 weeks, effective January 22, 2022. The proposed curriculum consists of 675 theory hours and 955 clinical hours, totaling 1630 hours.

- **American Career College, Anaheim (Orange County), Vocational Nursing Program – Requests Approved.**

The Program requested the Board approve the Program's curriculum revision from a full-time curriculum of 54 weeks to a revised full-time curriculum of 55 weeks, effective January 22, 2022. The proposed curriculum consists of 675 theory hours and 955 clinical hours, totaling 1630 hours.

- **American Career College, Ontario, Vocational Nursing Program – Requests Approved.**

The Program requested the Board approve the Program's curriculum revision from a full-time curriculum of 54 weeks to a revised full-time curriculum of 55 weeks, effective January 22, 2022. The proposed curriculum consists of 675 theory hours and 955 clinical hours, totaling 1630 hours.

- **California Career Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time evening class of 30 students to commence on February 8, 2022, with an expected graduation date of September 3, 2023 to replace the class that graduated on November 19, 2021.

- **Carrington College San Jose, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on January 17, 2022 with a graduation date of December 16, 2022 which will replace the class graduating on December 17, 2021

- **College of the Siskiyous, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning February 2, 2022 and issue a certificate accordingly.

- **Concorde Career College North Hollywood, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a part-time term 4 class of 29 students, one-time only, beginning February 1, 2022 and graduating October 23, 2022.

Additionally, the Program requested the Board approve the Program's request to increase the frequency of admissions for part time classes from one part-time class of 30 students per calendar year, replacing graduating classes only, to two part-time classes of 30 students per calendar year, replacing graduating classes only.

- **Concorde Career College West Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested the Board approve the voluntary closure of the Concorde Career College, West Los Angeles Program, effective February 1, 2022.

- **Medical Allied Career Center, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 20 students to commence on March 28, 2022 with a projected graduation date of October 18, 2023, to replace the class that graduates on April 24, 2022.

- **Medical Career College, Vocational Nursing Program – Request Approved.**

The Program requested the Board approve a full-time class of 36 students on April 18, 2022, to graduate on April 7, 2023. This is not a replacement class.

- **Mission College, Psychiatric Technician Program – Request Approved.**

The Program requested the Board approve the voluntary closure of the Mission College Psychiatric Technician Program, effective December 16, 2021

- **National Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time evening class of 30 students to commence on January 27, 2022, with a graduation date of April 22, 2023.

- **San Joaquin Valley College Rancho Mirage, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on June 27, 2022, with a graduation date of October 6, 2023.

- **The Nurse Academy, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 24 students to commence on March 21, 2022, with an expected graduation date of April 28, 2023 to replace the class who will be graduating on March 31, 2022.

- **Unitek College Sacramento, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time evening class of 36 students to commence on February 22, 2022, with a graduation date of August 26, 2023, to replace the class that graduates on February 5, 2022. This class is not part of the ongoing pattern of admissions

Effective January 25, 2022:

- **California Nurses Educational Institute, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning February 1, 2022 and issue a certificate accordingly.

- **Institute of Technology Clovis, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students commencing March 14, 2022, graduating April 14, 2023, to replace the April 15, 2022, graduating class.

- **Institute of Technology Modesto, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time day class of 30 students commencing March 14, 2022, graduating April 9, 2023, to replace the December 10, 2021 graduating class.

Additionally, the Program requested to admit a full-time evening class of 15 students commencing March 14, 2022, graduating April 9, 2023.

- **Xavier College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning February 2, 2022 and issue a certificate after the payment for program fees have been paid and cleared.

Effective February 8, 2022:

- **Cerro Coso Community College, Vocational Nursing Program – Request Approved.**

The Program requested to admit two cohorts of 15 students to commence on August 22, 2022, with a graduation date of November 30, 2023, to replace two cohorts of students who graduated on December 2, 2021.

- **Nurses' Development Center, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 30 students to commence on March 7, 2022 with a graduation date of October 29, 2023

- **North-West College, Van Nuys, Vocational Nursing Program – Request Approved.**

The Program requested to change the current approved pattern of admissions of two full-time day and two full-time evening classes of 30 students to four full-time evening classes of 30 students to commence with the next class starting on May 4, 2022.

- **Stanbridge University, Irvine, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 45 students to commence on February 21, 2022, with a graduation date of August 27, 2023, replacing the February 7, 2022 graduating class.

Additionally, the Program requested the Board approve the Program's curriculum revision from a full-time curriculum of 54 weeks to a revised full-time curriculum of 60 weeks, effective February 21, 2022. The proposed curriculum consists of 623 theory hours and 978 clinical hours, totaling 1601 hours.

The proposed curriculum consists of 623 theory hours and 978 clinical hours, totaling 1601 hours.

- **Summit College, El Cajon, Vocational Nursing Program – Request Approved.**

The Program requested the Board approve the Program's part-time curriculum of 84 weeks. The proposed curriculum consists of 632 theory hours and 954 clinical hours, totaling 1586 hours.

- **Summit College, San Bernardino, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 30 students to commence on February 14, 2022, with an expected graduation date of February 10, 2023. This class is in addition to the three existing full-time day cohorts.

Effective March 8, 2022:

- **Angeles Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 40 students to commence on April 4, 2022, with a graduation date of February 3, 2023, to replace a class that graduated on February 4, 2022.

- **Beaumont Adult School, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 30 students to commence on April 12, 2022 with a graduation date of October 21, 2023, to replace the class graduating March 17, 2022.

- **California Career Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time evening class of 30 students to commence on March 15, 2022, with an expected graduation date of October 19, 2023, to replace the class graduating on March 9, 2022.

- **Carrington College, Sacramento, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on March 28, 2022 with a graduation date of March 10, 2023, to replace the class graduating March 25, 2022.

- **Cordoba Medical Institute, Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant initial approval for the four-year period beginning March 8, 2022 and issue the certificate accordingly.

Additionally, the Program requested to begin a vocational nursing program with an initial full-time class of 30 students on June 6, 2022. The projected graduation date is May 26, 2023. The proposed 48-week full-time curriculum consists of 662 theory hours and 956 clinical hours, totaling 1618 program hours.

- **Gurnick Academy of Medical Arts, Concord, Vocational Nursing Program – Request Approved.**

The Program requested approval to adopt the revised full-time curriculum effective March 28, 2022, with the admission of the next cohort. The proposed curriculum consists of 616 theory hours and 954 clinical hours, totaling 1570 hours.

- **Gurnick Academy of Medical Arts, Fresno, Vocational Nursing Program – Request Approved.**

The Program requested approval to adopt the revised full-time curriculum effective March 28, 2022, with the admission of the next cohort. The proposed curriculum consists of 616 theory hours and 954 clinical hours, totaling 1570 hours.

- **Gurnick Academy of Medical Arts, Modesto, Vocational Nursing Program – Request Approved.**

The Program requested approval of the revised full-time curriculum effective March 28, 2022, with the admission of the next cohort. The proposed curriculum consists of 616 theory hours and 954 clinical hours, totaling 1570 hours.

- **High Desert Medical College, Bakersfield, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 23 students to commence on June 20, 2022, with a graduation date of August 22, 2023.

- **Marian College, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 16 students to commence on April 6, 2022 with a graduation date of June 8, 2023, to replace the class graduating March 31, 2022.

Additionally, the Program requested to admit a part-time class of 16 students to commence on April 8, 2022 with a graduation date of October 21, 2023, to replace the class graduating March 26, 2022.

- **North-West College, Anaheim, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 30 students to commence on May 2, 2022 with a graduation date of August 15, 2023. This request is for the third class in their program.

- **Quest Nursing Education Center, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a part-time day class of 30 students to commence on April 6, 2022 with a graduation date of June 30, 2023, to replace the class graduating March 31, 2022.

Additionally, the Program requested to admit a part-time evening class of 30 students to commence on April 6, 2022 with a graduation date of June 30, 2023, to replace the class graduating March 31, 2022.

- **San Bernardino Valley College, Psychiatric Technician Program – Request Approved.**

The Program requested the Board grant continued full approval of their program for a four-year period beginning February 7, 2022 and issue a certificate accordingly.

- **Visalia Adult School, Vocational Nursing Program – Request Approved.**

The Program requested approval to change the currently approved pattern of admissions of one full-time class of 60 students once a year to two full-time cohorts of 30 students twice a year to commence with the next class starting on January 9, 2023. Future replacement classes will occur in January and August each year after the existing class of 30 students has graduated. This program will not have more than two classes of 30 students at one time.

- **Westchester College of Nursing and Allied Health, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on September 12, 2022, with a graduation date of February 26, 2024.

Effective March 22, 2022:

- **Allan Hancock College, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning April 11, 2022 and issue a certificate accordingly.

- **Angeles College, City of Industry, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 25 students commencing on March 28, 2022, graduating on April 14, 2023. This is an additional class to the existing three cohorts.

- **Baldy View Regional Occupational Program, Vocational Nursing Program – Request Approved.**

The Program requested the Board grant continued full approval for a four-year period beginning May 11, 2022 and issue a certificate accordingly.

- **Career Care Institute, Moreno Valley, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 30 students commencing on March 28, 2022, graduating on July 23, 2023. This class will replace the class which graduated on February 16, 2022.

- **Carrington College, San Jose, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on May 9, 2022, with a graduation date of April 21, 2023, which will replace the class graduating on April 22, 2022.

- **Healthcare Science Academy, Vocational Nursing Program – Requests Approved.**

The Program requested the Board grant initial approval for the four-year period beginning March 22, 2022 and issue the certificate accordingly.

Additionally, the Program requested approval of their 53-week full-time curriculum. Each of the five terms are 10-11 weeks in length including 654 theory hours and 1004 clinical, totaling 1658 program hours.

Additionally, the Program requested an initial full-time class of 24 students on September 6, 2022, only, and graduating November 3, 2023.

- **Nurses' Development Center, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on May 2, 2022, with a graduation date of April 14, 2023.

- **North-West College, Anaheim, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 30 students to commence on July 5, 2022, with a graduation date of October 2, 2023.

- **North-West College, Riverside, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time evening class of 30 students to commence on April 18, 2022, with a graduation date of August 18, 2023, to replace the class graduating April 14, 2022.

- **North-West College, West Covina, Vocational Nursing Program – Request Approved.**

The Program requested to increase the class size from 35 to 45 students starting with the cohort commencing on May 11, 2022.

- **San Joaquin Valley College, Rancho Mirage, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on October 17, 2022, with a graduation date of June 7, 2024.
