Subject: Education Division Report

Site Visits

The Nursing Education Consultants (NEC's) have continued conducting site visits, mostly related to the continued approval process for programs known as the Program Records Survey (PRS). During the period of April 1, 2022, to June 30, 2022, the NEC's conducted 23 site visits.

Issues and Challenges During the Pandemic:

The NEC's continue to communicate with Program Directors to ensure that the programs are complying with regulations and that the students are not negatively impacted by loss of clinical sites due to the COVID-19 pandemic. Vocational Nursing and Psychiatric Technician programs faced many challenges during the past two years and have been creative with various clinical modalities to continue to move their students forward. The NEC's will continue working with the 29 programs who are still in need of alternative modalities for accomplishing clinical hours due to the COVID-19 pandemic.

Initial Approval of New School Programs

Six of the nine new school program applications have been received from the initial cohort (Cohort 1) of applicants who were on the Board's waiting list on or before December 31, 2019 and submitted a Letter of Intent by February 2, 2022. These six proposed programs have been assigned to an NEC.

We are preparing to conduct online training sessions during Fall 2022 via MS Teams for prospective proposed programs. The online training sessions will assist proposed program administrators and staff with preparing the documentation of the new school program application. These online sessions will be recorded and later emailed to all attendees.

Staff Updates

The Governor's 2022-23 Budget includes funds specifically to hire two additional NEC's and one Associate Government Program Analyst (AGPA) to assist with the new school program application process which began January 2022. In addition, we have one vacant Program Technician position. We are currently conducting interviews for those positions.

Directors Forum

The Education Division holds semi-annual forums with Vocational Nursing and Psychiatric Technician Program Directors. The Fall 2022 Director Forum is scheduled for September 14 and September 15, 2022, via WebEx. We are currently scheduling guest speakers to present content requested by the Program Directors on the evaluations from the prior Spring 2022 forum. One guest speaker from the National Council State Boards of Nursing (NCSBN) will be scheduled as one of the guest speakers.

Organizational Improvement Office

DCA's Organizational Improvement Office (OIO) provides DCA boards and bureaus with change management services, business process mapping, and information technology system requirement documentation as well as collaborative consulting on process reengineering that maximizes utilization of existing resources, improves productivity, and increases quality. With the assistance of the OIO, the Education Division completed the mapping process for identifying steps of specific tasks within the Division. The OIO is preparing their report detailing specific recommendations on improving efficiencies throughout the Education Division. The final report will be presented to the Executive Officer (EO) for review. The report and recommendations will be presented to the Board at a future meeting.








