Please note: The NECs make recommendations. The recommendations are forwarded to the Executive Officer Review, the Education and Practice Committee or the full Board for action.

PROGRAM REQUEST:

The Program requests to be removed from provisional approval and returned to continued full approval.

The Program requests to admit a full-time class of 20 students commencing on September 26, 2022, and graduating on September 29, 2023, to replace the class that graduates on September 30, 2022.

BACKGROUND:

On June 13, 2022, the NEC received a request with supporting documentation from the Program Director for a request for reconsideration of provisional approval and a request to admit students.

STAFF ANALYSIS:

The Program was approved to begin a vocational nursing program on February 6, 2018. On August 21, 2020, the Program was placed on provisional approval for a two-year period due to noncompliance with regulatory requirements, specifically, the NCLEX-PN® pass rates were significantly below the state average annual pass rate for first-time candidates.

Currently, the Program's average annual pass rate is 100 percent, 28 percentage points above the state average.

The Program's first cohort graduated five students on April 26, 2019. Of the five graduates, four have taken the NCLEX-PN® examination and failed, and one has not taken the NCLEX-PN® examination. The Program was then placed on provisional approval.

The Program's second cohort graduated five students on October 16, 2020. Of the five graduates, four have taken the NCLEX-PN® examination and passed, and one student failed. The Program has an 80 percent quarterly pass rate for this cohort, during the period of January through March 2021.

The Program's third cohort graduated five students on April 29, 2022. Of the five students, two have taken the NCLEX-PN® examination during the period of April 2022 through June 2022 and both passed. Of the remaining three students, one took the NCLEX-PN® examination in July 2022, the other two are scheduled to take the NCLEX-PN® examination in August 2022.

The Program submitted a comprehensive analysis on May 31, 2022. To increase the Program pass rates and ensure ongoing compliance with regulatory requirements, the Program has implemented the following:

- 1. Revised the curriculum to increase the medical surgical component including community health, geriatrics, and mental health.
- 2. Initiated the ATI Board vitals, Capstone, and NCLEX Live review.
- 3. Implemented the ATI Supreme mastery package. The supreme package includes specialty-focused review as students move from Term I to Term IV, 3-day live review and exit examination.
- 4. Initiated faculty development to strengthen faculty effectiveness in the transfer of knowledge and skills. Faculty development will be offered twice a year.
- 5. Implemented consistency with theory and clinical instructions through an instructional team approach. Theory instructors will go with clinical groups to the clinical area to enhance student learning and the application of concepts to clinical practice.
- 6. Changed medical-surgical course textbook to Wolters-Kluwer and used new teaching strategies such as case studies, smart classroom, and integrated evidence-based scenarios to emphasize key points and critical elements.
- 7. The Program implemented a remediation algorithm to help students who are struggling.

On July 15, 2022, the NEC conducted a virtual site visit and interviewed two groups of students online. All students agreed they would recommend the program to family members or friends. Students stated the best part of the program was the direct-patient care clinical experience and support of instructors. Students stated clinical hours are completed in direct patient care settings. According to the students, clinical make-up hours are completed at the clinical sites.

The NEC reviewed and analyzed the documents provided by the Program Director to verify adequate resources including clinical facilities and classrooms to accommodate the students' learning needs and ability to meet the Program's approved objectives. The Program can place students into approved clinical facilities for clinical experiences and is conducting theory on campus. The Program was reviewed to determine compliance with Article 5 of the California Code of Regulations, Title 16. No violations were identified.

STAFF RECOMMENDATIONS:

- 1. Grant continued full approval for the Southeast Career College Vocational Nursing Program for a four-year period beginning August 12, 2022 and issue a certificate accordingly.
- 2. Approve the Program's request to admit a full-time class of 20 students commencing on September 26, 2022, and graduating on September 29, 2023, to replace the class that graduates on September 30, 2022.
- 3. Require the Program to comply with all requirements listed below.

- 1. Obtain BVNPT approval prior to the admission of each class.
- 2. Require the Program, when requesting approval to admit students, to:
 - a. Submit all documentation in final form, using forms provided by the BVNPT, no later than two months prior to the requested start date for the class.
 - b. Provide documentation that adequate resources, i.e., faculty and facilities, are available to support each admitted class of students.
 - c. Ensure that the Program maintains an average annual pass rate that is compliant with Section 2530(I) of the California Code of Regulations, Title 16.
- 3. Continue to provide no less than one instructor for every ten students in clinical experiences. Section 2534(d) of the California Code of Regulations, Title 16, states, "For supervision of clinical experience, there shall be a maximum of 15 students for each instructor." The recommendation of one instructor for every ten students in clinical experiences will enable more focused instruction and enhanced learning to closely monitor and evaluate the clinical performance of students.
- 4. Notify the NEC in the event a current class is displaced from clinical sites.

- 5. Continue the Program's requirement to comply with all approval standards in Article 4 of the Vocational Nursing Practice Act, commencing at the California Business and Professionals Code, Section 2880, and Article 5 of the California Code of Regulations, Title 16.
- 6. Continue to monitor the Program's effectiveness by tracking class admissions, the effectiveness of employed interventions, and the Program's licensure examination pass rates each quarter.

RELEVANT PROGRAM ELEMENTS

Enrollment

Section 2530(k) of the California Code of Regulations, Title 16 states:

"The program shall have prior Board approval to increase the number of students per class and/or increase the frequency of admission of classes. Criteria to evaluate a school's request to increase the number of students per class and/or increase the frequency of class admissions include but are not limited to: (1) Sufficient program resources as specified in Section 2530(a). (2) Adequacy of clinical experience as specified in Section 2534. (3) Licensure examination pass rates as specified in Section 2530(l)".

The Program is approved to offer a 52-week full-time class. Board approval is required prior to the admission of each class.

The following table represents current and projected student enrollment based on current and proposed class starts and completion dates. The table indicates a maximum enrollment of 35 students for the period September 2021 through September 2022.

Licensing Examination Statistics

Section 2530(I) of the California Code of Regulations, Title 16 states:

"The program shall maintain a yearly average minimum pass rate on the licensure examination that does not fall below 10 percentage points of the state average pass rate for first time candidates of approved vocational nursing schools for the same period."

The following statistics, furnished by Pearson Vue and published by the National Council of State Boards of Nursing as "Jurisdictional Summary of All First-Time Candidates Educated in Member Board Jurisdiction," for the period July 2020 through June 2022, specify the pass percentage rate for graduates of the Program on the National Council Licensure Examination for Practical/Vocational Nurses (NCLEX-PN®) and the variance from the state average annual pass rates.

^{*}The Annual Pass Rate changes every quarter. It is calculated by dividing the number of candidates who passed during the current and previous three quarters by the number of candidates who tested during the same period. If no data is available for the relevant period, the statistic is carried over from the last quarter for which data is available.

Based on the most current data available (April – June 2022), the Program's average annual pass rate is 100 percent. The California average annual pass rate for graduates from approved vocational nursing programs who took the NCLEX-PN® for the first time during the same period is 72 percent. The average annual pass rate for the Program is 28 percentage points above the state average annual pass rate.

Faculty and Facilities

Section 2534(d) of the California Code of Regulations, Title 16 states:

"For supervision of clinical experience, there shall be a maximum of 15 students for each instructor."

The current number of approved faculty totals 11, including the Program Director. The Program Director has 90 percent administrative duties and 10 percent teaching responsibilities. Of the total faculty, six are designated to teach clinical.

At the August 21, 2020, Board meeting, the Program was required to provide no less than one instructor for every ten students in clinical experiences.

Based upon a maximum proposed enrollment of 35 students, four instructors are required for clinical supervision. The utilization of faculty at clinical facilities is such that clinical instruction is covered adequately.

Section 2534(b) of the California Code of Regulations, Title 16, states:

"Schools shall have clinical facilities adequate as to number, type, and variety of patients treated, to provide clinical experience for all students in the areas specified by Section 2533. There must be available for student assignment, an adequate daily census of patients to afford a variety of clinical experiences consistent with competency-based objectives and theory being taught."

Submitted documentation indicates the Program has sufficient clinical facilities to afford the number, type and variety of patients that will provide clinical experience consistent with Board-approved competency-based objectives and theory being taught for current and proposed student enrollment.

SOUTHEAST CALIFORNIA COLLEGE VOCATIONAL NURSING PROGRAM

Program History

- On February 6, 2018, the Executive Officer approved Southeast California College, to begin a vocational nursing program with an initial class of 24 students on February 12, 2018, only.
- The Program curriculum was approved for 1546 hours, including 578 theory hours, and 968 clinical hours.
- Require the Program to obtain prior Board approval before admission of subsequent classes to maintain compliance with the California Code of Regulations, Title 16, section 2526(c) that states:
 - "(c) A Board representative shall make a survey visit prior to graduation of the initial class. A program shall not commence another class without prior Board approval."
- On April 2, 2019, the Executive Officer, approved the following:
 - 1. Grant full approval for the Southeast California College, Vocational Nursing Program for a four-year period beginning February 6, 2018, and issue a certificate accordingly.
 - 2. Require the Program to correct sixteen existing violations identified during the onsite inspection and one additional violation identified after the visit. Submit documentation of all corrections of all violations no later than May 3, 2019.
 - 3. Require the Program to admit no additional classes without prior Board approval.
 - 4. Continue to require the Program, when requesting approval to admit students, to:
 - a. Submit all documentation in final form, using the forms provided by the Board, no later than two months prior to the requested start date for the class.
 - b. Provide documentation that adequate resources, i.e., faculty and facilities, are available to support each admitted class of students.

- c. Ensure that the Program maintains an average annual pass rate that is compliant with Section 2530(I) of the California Code of Regulations, Title 16.
- 5. Require the Program's requirement to comply with all approval standards in Article 4 of the Vocational Nursing Practice Act, commencing at Business and Professions Code Section 2880, and Article 5 of the California Code of Regulations, Title 16 commencing at Section 2526.
- On September 17, 2019, the Executive Officer, approved the following
 - 1. Approve the Southeast California College, Vocational Nursing Program request to admit one class of 16 students on September 23, 2019, only.
 - 2. Require the Program to admit no additional classes without prior approval by the Board.
 - 3. Require the Program, when requesting approval to admit students, to:
 - a. Submit all documentation in final form, using the forms provided by the Board, no later than two months prior to the requested start date for the class.
 - b. Provide documentation that adequate resources, i.e., faculty and facilities, are available to support each admitted class of students.
 - c. Ensure that the Program maintains an average annual pass rate that is compliant with Section 2530(I) of the California Code of Regulations, Title 16.
 - 4. Approve the Program's request to admit a full-time class of 20 students to commence on April 4, 2022, with a graduation date of April 14, 2023, to replace the class who will graduate on April 15, 2022.
 - 5. Require the Program to comply with all requirements listed below.

- On August 21, 2020, the Board, approved the following
 - 1. Deny the Southeast California College, Vocational Nursing Program request to admit one class of 17 students on August 3, 2020, only.
 - Place the Southeast California College, Vocational Nursing Program on provisional approval for the two-year period beginning August 21, 2020; and issue a certificate accordingly.
 - Issue a notice of change in approval status to the Program identifying specific areas of non-compliance and requirements for correction as referenced in Section 2526.1 and Section 2530(I) of the California Code of Regulations, Title 16.
 - 4. Require the Program to submit an action plan to correct their NCLEX-PN[®] first time takers score of zero percent passing by October 1, 2020.
 - 5. Require the Program to admit no additional classes without prior approval by the Board.

- 6. Continue the Program's requirement to comply with all approval standards in Article 4 of the Vocational Nursing Practice Act, commencing at the California Business and Professionals Code, Section 2880, and Article 5 of the California Code of Regulations, Title 16, Section 2526.
- 7. Continue the Program's requirement to demonstrate incremental progress in NCLEX-PN® examination pass rates. If the Program fails to satisfactorily demonstrate incremental progress, the full Board may revoke the Program's approval.
