Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from July 12, 2022 to October 4, 2022.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective July 12, 2022:

- **Career Care Institute, Inc., Oxnard (previously Ventura), Vocational Nursing Program – Requests Approved.**

The Program requested continued full approval for a four-year period beginning August 25, 2022 and issue the certificate accordingly.

Additionally, the Program requested to admit a full-time evening class of 40 students commencing on August 15, 2022, graduating on December 3, 2023, to replace the class that graduated on July 24, 2022.

Effective July 26, 2022:

- **California Career College, Vocational Nursing Program – Request Approved.**
- **Cordoba Medical Institute, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 15 students to commence on August 15, 2022, with a graduation date of September 6, 2023.

The Program requested the addition of a part-time curriculum of 64 weeks, effective July 26, 2022. The proposed curriculum consists of 662 theory hours and 956 clinical hours totaling 1618 hours.

Additionally, the Program requested a change of date for the initial full-time class of 30 students from June 6, 2022, to a part-time class of 30 students on September 6, 2022, and graduating on January 26, 2024.

- **Honor Health Sciences, Vocational Nursing Program – Requests Approved.**

The Program requested initial approval for the four-year period beginning July 26, 2022 and issue the certificate accordingly.

Additionally, the Program requested approval to begin a vocational nursing program with an initial full-time class of 24 students on September 12, 2022, only, and graduating on September 22, 2023.

Additionally, the Program requested approval of its 50-week full-time curriculum, five 10-week terms of 1629 Program hours, including 637 theory hours and 992 clinical hours.

- **Institute of Technology, Clovis, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time day class of 30 students to commence on November 7, 2022, with a graduation date of December 8, 2023, replacing the December 9, 2022, graduating class.

Additionally, the Program requested a pattern of admission to include three full-time day classes and one full-time evening class of 30 students per calendar year, replacing graduating classes only.

- **Institute of Technology, Modesto, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time day class of 30 students to commence on November 7, 2022, with a graduation date of December 18, 2023, replacing the December 9, 2022, graduating class.

Additionally, the Program requested a pattern of admission to include three full-time day classes and one full-time evening class of 30 students per calendar year, replacing graduating classes only.

Effective August 9, 2022:

- **Career Care Institute, Moreno Valley, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 30 students commencing on September 5, 2022, graduating on January 14, 2024, to replace the class that will graduate on August 21, 2022.

- **Summit College, El Cajon, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time day class of 20 students to commence on August 16, 2022, with an expected graduation date of August 11, 2023.

- **Summit College, San Bernardino, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time day class of 30 students to commence on August 10, 2022, with an expected graduation date of August 11, 2023. This cohort will replace the cohort which will graduate on August 12, 2022.

Additionally, the Program requested to admit a part-time evening class of 30 students to commence on October 10, 2022, with an expected graduation date of May 19, 2024, to replace the cohort which graduated on June 26, 2022.

- **National Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on November 7, 2022, with a graduation date of February 28, 2024, to replace the October 19, 2022, graduating class.

Effective August 23, 2022:

- **American Career College, Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period commencing October 11, 2022.

- **Beaumont Adult School, Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 30 students to commence October 11, 2022, and graduate April 11, 2024.

- **California Career Institute, Los Angeles, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 30 students to commence September 13, 2022, and graduate April 19, 2024.

- **Carrington College, Sacramento, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students commencing November 14, 2022, with a graduation date of November 27, 2023.

- **Hacienda La Puente Adult Education, Willow Center, Psychiatric Technician Program – Requests Approved.**

The Program requested continued full approval for a four-year period commencing August 24, 2022.

Additionally, the Program requested a curriculum revision to include 1520 total program hours to include 616 theory and 960 clinical hours.

- **High Desert Medical College, Temecula, Vocational Nursing Program – Requests Approved.**

The Program requested initial approval for the four-year period beginning August 23, 2022 and issue the certificate accordingly.

Additionally, the Program requested to admit a full-time class of 25 students to commence on September 12, 2022 and graduating on November 27, 2023.

Additionally, the Program requested approval of its 56-week full-time curriculum with the total program hours 1679 hours to include 724 theory and 955 clinical hours.

- **San Joaquin Valley College, Rancho Mirage, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period, commencing August 25, 2022.

- **Stanbridge University, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested continued full approval commencing August 25, 2022, to replace the October 19, 2022, graduating class.

Additionally, the Program requested to admit a part-time class of 45 students September 26, 2022, graduating on February 7, 2025.

Additionally, the Program requested to admit a full-time class of 45 students on October 10, 2022, and graduate on April 26, 2024.

Additionally, the Program requested a pattern of admission to include four full-time day classes, three part-time day classes of 45 students per calendar year.

- **Unitek College, Concord, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 36 students to commence on September 12, 2022, with a graduation date of August 25, 2023.

Additionally, the Program requested to increase the pattern of admission from five to six classes of 35 students.

Effective September 6, 2022:

- **Angeles College, City of Industry, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 30 students to commence on October 10, 2022, with a graduation date of November 24, 2023. This class will be an additional class.

Additionally, the Program requested a pattern of admission to include four full-time day classes and one part-time day classes of 30 students per calendar year, replacing graduating classes only. This Program will not have more than five cohorts at any one time.

- **Angeles Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 45 students to commence on October 3, 2022, with a graduation date of August 6, 2023, to replace a class that graduated on August 5, 2022.

- **Blake Austin College, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning on September 15, 2022 and issue a certificate accordingly.

- **Marian College, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 20 students to commence on October 19, 2022, with a graduation date of February 5, 2024, to replace the class graduating on October 11, 2022.

Additionally, the Program requested to admit a part-time class of 20 students to commence on November 4, 2022, with a graduation date of July 12, 2024, to replace the class graduating on October 29, 2022.

- **Medical Allied Career Center, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 20 students to commence on October 24, 2022, with a graduation date of May 15, 2024, to replace the class that will graduate on October 23, 2022.

- **Northwest College, Anaheim, Vocational Nursing Program – Request Approved.**

- **Summit College, San Bernardino, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning September 14, 2022 and issue a certificate accordingly.

Effective September 20, 2022:

- **High Desert Medical College, Bakersfield, Vocational Nursing Program – Requests Approved.**

The Program requested continued full approval for a four-year period beginning November 1, 2022 and issue a certificate accordingly.
