Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from January 3, 2023 to April 3, 2023.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective January 3, 2023:

- **Allied Medical & Health Services, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time day class of 12 students to commence on January 21, 2023, with a graduation date of June 25, 2024.

- **California Career Institute, Vocational Nursing Program – Request Approved.**

The Program requested to increase the class size from 30 students to 45 students effective January 23, 2023.

- **Carrington College, San Jose, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on March 13, 2023, with a graduation date of February 23, 2024.

- **Clement Career College, Vocational Nursing Program – Requests Approved.**

The Program requested initial approval for the four-year period beginning January 3, 2023 and issue a certificate accordingly.

Additionally, the Program requested approval of a 48-week full-time curriculum, four 12-week terms of 1600 hours, including 640 theory hours and 960 clinical hours.

- **Dalrada Career Institute, Vocational Nursing Program – Requests Approved.**

The Program requested initial approval for the four-year period beginning January 3, 2023 and issue a certificate accordingly.

Additionally, the Program requested approval of a 50-week full-time curriculum, five 10-week terms of 1530 hours, including 576 theory hours and 954 clinical hours.

- **National Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on March 13, 2023, with a graduation date of June 26, 2024, to replace the March 6, 2023, graduating class.

- **North-West College, Long Beach, Vocational Nursing Program – Request Approved.**

The Program requested to increase the class size from 30 to 45 students, four times a year, to start with the cohort on April 24, 2023.

- **North-West College, Pomona, Vocational Nursing Program – Request Approved.**

The Program requested to increase the class size from 40 to 45 students, four times a year, to start with the cohort on February 15, 2023.

- **North-West College, Van Nuys, Vocational Nursing Program – Request Approved.**

The Program requested to increase the class size from 30 to 45 students four times a year, to start with the cohort on May 4, 2023.

- **San Joaquin Valley College, Rancho Mirage, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 20 students to commence on February 27, 2023, with a graduation date of June 7, 2024, to replace the February 17, 2023, class.

- **The Nurse Academy, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 24 students to commence on February 6, 2023, with a graduation date of March 28, 2024.

- **Universal Healthcare Careers College, Vocational Nursing Program – Requests Approved.**

The Program requested initial approval for the four-year period beginning January 3, 2023 and issue a certificate accordingly.

Additionally, the Program requested approval of a 54-week full-time curriculum, three 18-week terms of 1580 hours, including 613 theory hours and 967 clinical hours.

Effective January 17, 2023:

- **Professional Medical Careers Institute, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning February 24, 2027 and issue a certificate accordingly.

- **Marian College, Los Angeles, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 20 students to commence on March 8, 2023, with a graduation date of May 28, 2023, to replace the class that graduates on February 22, 2023.

Additionally, the Program requested to admit a part-time class of 20 students to commence on March 24, 2023, with a graduation date of November 23, 2024, to replace the class that graduates on March 8, 2023.

- **Pacific Times Healthcare College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on May 8, 2023, with a graduation date of July 25, 2024.

Effective January 31, 2023:

- **North-West College, West Covina, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning February 22, 2023 and issue a certificate accordingly.

- **Summit College, San Bernardino, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time day class of 20 students to commence on March 13, 2023, with an expected graduation date of March 8, 2024, replacing the cohort that graduates on February 10, 2023.

Additionally, the Program requested to admit a part-time evening class of 20 students to commence on March 6, 2023, with an expected graduation date of October 13, 2024, replacing the cohort that graduated on November 20, 2022.

- **Sunrise School of Nursing, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 15 students to commence on March 6, 2023, with a graduation date of March 4, 2024. This is the Program's first class of students.

- **Ukiah Adult School, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning February 28, 2023 and issue a certificate accordingly.

Effective February 14, 2023:

- **Advanced College, South Gate, Vocational Nursing Program – Requests Approved.**

The Program requested voluntary closure effective February 14, 2023.

Additionally, the Program requested removal of the Program from the List of Approved Vocational Nursing Programs.

Effective February 28, 2023:

- **Angeles Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 45 students to commence on April 2, 2023, with a graduation date of February 2, 2024, to replace students that graduated on February 3, 2023.

- **Annenberg School of Nursing, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning July 24, 2023 and issue a certificate accordingly.

- **California Career Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 45 students to commence on March 14, 2023, with a graduation date of October 18, 2024. The class will replace the students who graduate on March 11, 2023.

- **Career Care Institute, Moreno Valley, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time day class of 30 students to commence on March 20, 2023, with a graduation date of July 14, 2024, to replace the class that graduates on April 23, 2023.

Additionally, the Program requested a pattern of admission to include a class of 30 full-time students every three months alternating day and evening classes. Due to the length of the curriculum the Program would have five actively enrolled classes of students on campus.

- **Career Care Institute, Oxnard, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 40 students to commence on March 20, 2023, with a graduation date of July 14, 2024. This is a replacement class, for the cohort that graduated on December 18, 2022.

- **Gurnick Academy of Medical Arts, Concord, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning July 22, 2023 and issue a certificate accordingly.

- **High Desert Medical College, Bakersfield, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 23 students to commence on April 3, 2023, with a graduation date of June 5, 2024. The class will replace the class that graduates on March 23, 2023.

- **Medical Allied Career Center, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 20 students to commence on March 21, 2023, with a graduation date of September 27, 2024, to replace the class that will graduate on March 26, 2023.

- **Los Angeles Unified School District (LAUSD) North Valley Occupational Center, Vocational Nursing Program – Request Approved.**

The Program requested initial approval for the four-year period beginning January 31, 2023 and issue a certificate accordingly.

- **Nurses' Development Center, Inc., Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time class of 20 students to commence on March 13, 2023, with a graduation date of November 3, 2024.

- **Visalia Adult School, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning April 10, 2023 and issue a certificate accordingly.

Effective March 14, 2023:

- **California Healthcare Skills Center, Vocational Nursing Program – Request Approved.**

The Program requested to admit a class of 15 full-time students to commence on September 11, 2023, with a graduation date of September 30, 2024. This will be the second class for this program.

- **Contra Costa Medical Career College, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students to commence on May 10, 2023, with an expected graduation date of June 21, 2024.

- **North-West College, Riverside, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 45 students to commence on April 24, 2023, with an expected graduation date of July 19, 2023.

- **Unitek College, South San Francisco, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time evening class of 36 students to commence on May 9, 2023, with an expected graduation date of November 16, 2024.

Effective April 3, 2023:

- **Career Care Institute, Lancaster, Vocational Nursing Program – Request Approved.**

The Program requested continued full approval for a four-year period beginning April 9, 2023 and issue a certificate accordingly.

- **Central Coast College, Vocational Nursing Program – Requests Approved.**

The Program requested initial approval for the four-year period beginning April 3, 2023 and issue a certificate accordingly.

Additionally, the Program requested approval of a 59-week full-time curriculum, with five terms consisting of one eight-week, two 14-week, one ten-week, and one 13-week terms, with a total of 1,679 hours, including 716 theory hours and 963 clinical hours.

- **North-West College, Anaheim, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 30 students on April 4, 2023, with a graduation date of July 15, 2024, to replace the class that graduated on February 23, 2023.
