Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from April 11, 2023, to June 27, 2023.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective April 11, 2023:

- **Angeles Institute, Vocational Nursing Program – Request Approved.**

The Program requested to admit a full-time class of 45 students to commence on July 3, 2023, with a graduation date of May 3, 2024. This will replace the cohort that graduates in May 2023.

- **Beaumont Adult School, Vocational Nursing Program – Request Approved.**

The Program requested to admit a part-time day class of 30 students to commence on April 24, 2023, with a graduation date of October 18, 2024. This will replace the class graduating on April 28, 2023.

- **Cerro Coso Community College, Vocational Nursing Program – Requests Approved.**

The Program requested to admit a full-time class of 15 students to commence on August 21, 2023, with a graduation date of December 5, 2024. This will replace the class graduating on December 8, 2022.

The Program further requested a pattern of admission of one full-time class of 15 students every odd year and two full-time classes of 15 students every even year, only replacing graduating students.

- **Clovis Adult School, Vocational Nursing Program – Requests Approved.**

The Program requested continued full approval for a four-year period beginning June 20, 2023, and the issuance of a certificate accordingly.

The Program further requested the revision of an 18-month, part-time curriculum. The new curriculum would be an 18-month, part-time curriculum, effective April 11, 2023. The proposed curriculum consists of 672.5 theory hours and 957 clinical hours, totaling 1629.5 hours.

- **Concorde Career College, Garden Grove, Vocational Nursing Program – Request Approved**

The Program requested full approval for a four-year period beginning February 21, 2023, and the issuance of a certificate accordingly.

- **First Lady Permanente, Vocational Nursing Program – Requests Approved**

The Program requested to admit a full-time, day class of 30 students to commence on June 12, 2023, with a graduation date of May 9, 2024. This will be an initial class.

The Program further requested to revise the curriculum of the full-time, 52-week program effective June 12, 2023. The proposed curriculum consists of 581 theory hours and 958 clinical hours, totaling 1539 hours.

- **Hacienda La Puente Adult Education, Psychiatric Technician Program – Request Approved**

The Program requested to admit a full-time class of 20 students to commence on May 15, 2023, with a graduation date of August 2024.

- **Healthcare Career College, Vocational Nursing Program – Request Approved**

The Program requested to change the start date from March 13, 2023, to May 30, 2023, with a graduation date of August 26, 2024.

- **Imperial Valley College, Vocational Nursing Program – Request Approved**

The Program requested continued full approval for a four-year period beginning February 20, 2023, and the issuance of a certificate accordingly.

- **Los Angeles Unified School District, Maxine Waters Employment Preparation Center, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 15 students to commence on May 15, 2023, with a graduation date of July 12, 2024. This will replace the class graduating on December 16, 2022.

- **Medical Allied Career Center, Inc., Vocational Nursing Program – Request Approved**

The Program requested continued full approval for a four-year period beginning February 23, 2023, and the issuance of a certificate accordingly.

- **Palo Verde Community College, Vocational Nursing Program – Requests Approved**

The Program requested continued full approval for a four-year period beginning February 23, 2023, and the issuance of a certificate accordingly.

The Program further requested the revision of a 42-week Fast-Track program to be effective in Fall 2023. The proposed curriculum consists of 722 theory hours and 954 clinical hours, totaling 1676 hours.

- **Quest Nursing Education Center, Vocational Nursing Program – Requests Approved**

The Program requested to admit a part-time day class of 30 students to commence on April 17, 2023, with a graduation date of July 19, 2024. This will replace the class graduating on March 31, 2023.

The Program further requests to admit a part-time evening class of 30 students to commence on April 17, 2023, with a graduation date of July 19, 2024. This will replace the class graduating on March 31, 2023.

- **San Leandro Adult and Career Education Center, Vocational Nursing Program – Requests Approved**

The Program requested initial approval of the San Leandro Adult and Career Education Center Vocational Nursing Program for the four-year period beginning March 28, 2023, and the issuance of a certificate accordingly.

The Program further requested to admit a full-time class of 22 students to commence on August 12, 2023, with a projected graduation August 21, 2024.

The Program further requested the approval of a 50-week full-time curriculum, one 18-week term, and two 16-week terms of 1534 hours, including 578 theory hours and 956 clinical hours, totaling 1534 hours.

- **Southeast California College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 18 students to commence on May 8, 2023, with a graduation date of May 24, 2024. This will replace the class graduating on April 14, 2023.

Effective May 9, 2023:

- **California Career Institute, Centinela, Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time evening class of 45 students to commence on May 15, 2023, with a graduation date of January 3, 2025.

- **California Career Institute, Garden Grove, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 45 students to commence on June 19, 2023, with a graduation date of February 14, 2024. This will replace the class graduating on June 10, 2023.

- **Career Care Institute, Oxnard, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 40 students to commence on June 19, 2023, with a graduation date of October 8, 2024.

- **Clement Career College, Oxnard, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 30 students to commence on May 22, 2023, with a graduation date of May 24, 2024. This will be the initial class.

- **CNI College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 30 students to commence on June 12, 2023, with a graduation date of June 14, 2024. This will be the initial class.

- **Department of State Hospital Atascadero/Cuesta College, Psychiatric Technician Program – Request Approved**

The Program requested full approval for a four-year period beginning June 19, 2023, and the issuance of a certificate accordingly.

- **Gavilan College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 20 students to commence on May 30, 2023, with a graduation date of May 24, 2024. This is an additional one-time class.

- **Gurnick Academy, Sacramento, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 90 students to commence on July 03, 2023, with a graduation date of June 14, 2024. Forty-five students will be in a day class, and 45 students will be in evening class.

- **Hacienda La Puente Adult Education, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 20 students to commence on July 10, 2023, with a graduation date of August 01, 2024.

- **Homestead School, Inc., Costa Mesa, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on June 05, 2023, with a graduation date of June 14, 2024.

- **Medical Career College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 20 students to commence on June 20, 2023, with a graduation date of June 21, 2024.

- **Moriah Medical College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on August 21, 2023, with a graduation date of November 03, 2024.

- **National Career College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 30 students to commence on May 22, 2023, with a graduation date of September 12, 2024.

The Program further requested to admit a full-time evening class of 30 students to commence on June 21, 2023, with a graduation date of September 28, 2024. This will replace the class graduating on May 20, 2023.

- **North-West College, Riverside, Vocational Nursing Program – Requests Approved**

The Program requested to admit a full-time evening class of 45 students to commence on July 24, 2023, with a graduation date of November 01, 2024.

The Program further requested a pattern of admission to include a total of six full-time classes of 45 students in a calendar year, to replace graduating classes only starting with the July 24, 2023, class. This pattern includes three daytime classes and three evening classes.

- **Porterville Community College, Psychiatric Technician Program – Requests Approved**

The Program requested full approval for a four-year period beginning July 19, 2023, and the issuance of a certificate accordingly.

The Program further requested a curriculum revision from full-time of 18 months to a revised full-time curriculum of 18 months, effective August 21, 2023. The proposed curriculum consists of 576 theory hours and 972 clinical hours, totaling 1548 hours.

- **Summit College, El Cajon, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 24 students to commence on June 12, 2023, with an expected graduation date of June 07, 2024. This will replace the class graduating on May 12, 2023.

- **Summit College, San Bernardino, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 20 students to commence on June 12, 2023, with an expected graduation date of June 07, 2024. This will replace the class graduating on May 12, 2023.

- **Universal Healthcare Career College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 20 students to commence on August 21, 2023, with an expected graduation date of September 30, 2024. This will be the initial class.

Effective May 30, 2023:

- **Cuesta College, Vocational Nursing Program – Request Approved**

The Program requested continued full approval for a period of four years beginning April 12, 2023.

- **Medical Allied Career Center, Inc., Vocational Nursing Program – Request Approved**

The Program requested to admit part-time a class of 20 students on July 24, 2023, with a graduation date of March 2, 2025. This will be to replace class graduating on May 28, 2023.

- **Stanbridge University, Riverside, Vocational Nursing Program – Requests Approved**

The Program requested initial approval for the four-year period beginning May 23, 2023.

The Program further requested approval of the 60-week full-time curriculum, in six 10-week terms. This includes 623 theory hours and 978 clinical hours for a combined 1,602 hours total.

The Program further requested to begin an initial full-time class of 45 students on June 19, 2023, graduating on March 15, 2024.

- **The Nurse Academy, Vocational Nursing Program – Request Approved**

The Program requested approval a full-time class of 24 students to commence July 10, 2023, with a graduation date of August 26, 2024. This will replace the class graduating on July 18, 2023.

- **Tulare Adult School, Vocational Nursing Program – Requests Approved**

The Program requested to admit a part-time day class of 20 students to commence on August 16, 2023, with a graduation date of May 16, 2025.

The Program further requested a revised pattern of admission of one part-time day class of 30 students every 12 months (Fall Semester) to start with the August 2024 class. There will not be more than two classes at a time.

- **Unitek College, Hayward, Vocational Nursing Program – Recommendations Approved**

The NEC recommended placing the Program on the Education and Practice Committee Meeting agenda for June 26, 2023.

The NEC further recommended rescinding the Program's pattern of admission of three 46-week full-time day classes of 36 students per year to replace graduating students, one 62-week full-time evening class of 36 students per year, and two 75-week part-time evening weekend classes of 36 students to replace graduating students only.

The NEC further recommended requiring the Program to comply with all requirements listed on the Nursing Education Consultant's report.

- **West Hills Community College, Vocational Nursing Program – Requests Approved**

The Program requested to revise the curriculum from a full-time curriculum of 18 months to a revised full-time curriculum of 18 months, effective January 24, 2024. The proposed curriculum includes 675 theory hours and 972 clinical hours for a combined 1647 hours total.

The Program further requested to admit a full-time day class of 20 students commencing on January 16, 2024, graduating on May 16, 2025. This will be the initial class with the revised curriculum.

The Program further requested to rescind its pattern of admission for 30 students twice a year to replace graduating classes.

Effective June 7, 2023:

- **Bakersfield College, Vocational Nursing Program – Request Approved**

The Program's requested to increase the class size from 30 to 40 students, one time per calendar year, to start with the August 21, 2023, class

- **California Career College, Vocational Nursing Program – Request Approved**

The Program requested continued full approval for a four-year period beginning February 19, 2023, and the issuance of a certificate accordingly.

- **Carrington College, San Jose, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on July 10, 2023, with a graduation date of June 14, 2024. This will replace the class graduating on August 11, 2023.

- **Central Coast College, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 40 students to commence on August 14, 2023, with a graduation date of November 7, 2024. This will be an initial class.

- **Los Angeles Unified School District, North Valley Occupational Center, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 15 students to commence on July 10, 2023, with a graduation date of August 24, 2024. This will be an initial class.

- **North-West College, Anaheim, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students on July 3, 2023, with a graduation date of September 27, 2024. This will be an additional class.

- **Quest Nursing Education Center, Vocational Nursing Program – Requests Approved**

The Program requested to admit a part-time day class of July 10, 2023, with a graduation date of October 30, 2024. This will replace the class graduating on June 30, 2023.

The Program further requested to admit a part-time day class of July 10, 2023, with a graduation date of October 30, 2024. This will replace the class graduating on June 30, 2023.

- **San Joaquin Valley College, Rancho Mirage, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 20 students to commence on October 16, 2023, with a graduation date of February 14, 2025. This will replace the class graduating on October 6, 2023.

- **San Joaquin Valley College, Santa Maria, Vocational Nursing Program – Request Approved**

The Program requested to increase the class size from 25 to 30 students every 30 weeks beginning October 16, 2023. This will only be for replacing graduating classes.

- **Unitek College, San Jose, Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time evening class of students to commence on June 19, 2023, with a graduation date of December 19, 2023. This is not a part of their approved pattern of admission.

Effective June 27, 2023:

- **Antelope Valley College, Vocational Nursing Program – Request Approved**

The Program requested to increase the class size from 30 to 36 students one time per calendar year, replacing graduating classes only, to start with the August 14, 2023, class.

- **Bakersfield College, Vocational Nursing Program – Request Approved**

The Program requested to increase class size from 30 students to 36 students, one time per year. This will commence with the August 21, 2023, class.

- **College of the Desert, Vocational Nursing Program – Request Approved**

The Program requested continued approval for a four-year period beginning May 14, 2023, and the issuance of a certificate accordingly.

- **Cordoba Medical Institute, Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time class of 30 students to commence on July 18, 2023, with a graduation date of November 9, 2024.

- **Honor Health Sciences, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 24 students to commence on September 11, 2023, with a graduation date of September 21, 2024.

- **Marian College, Los Angeles, Vocational Nursing Program – Requests Approved**

The Program requested to admit a full-time class of 20 students to commence on August 2, 2023, with a graduation date of October 23, 2023.

The Program further requested to admit a part-time class of 20 students to commence August 4, 2023, with a graduation date of April 25, 2025, as a one-time additional class.

- **Shasta College, Vocational Nursing Program – Request Approved**

The Program requested continued approval for a four-year period beginning May 14, 2023, and the issuance of a certificate accordingly.

- **Unitek College, Sacramento, Vocational Nursing Program – Requests Approved**

The Program requested to admit a part-time evening class of 36 students to start July 31, 2023, with a graduation date of February 15, 2025.

The Program further requested to increase the pattern of admission from 10 classes to 12 classes. The new classes will be 84-week part-time evening weekend classes.
