Education Consultant Program Reports from July 18, 2023, to

October 10, 2023.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

#### Effective July 18, 2023:

 Allied Medical & Health Services, Inc., Vocational Nursing Program – Request Approved.

The Program requested to admit a part-time day class of 12 students to commence on August 17, 2023, with a graduation date of February 15, 2025.

• Angeles Institute, Vocational Nursing Program – Requests Approved.

The Program requested to admit a full-time class of 38 students to commence on October 2, 2023, with a graduation date of August 2, 2024, to replace the class graduating on August 6, 2023.

The Program further requested a pattern of admission of four full-time classes of 38 students per calendar year, replacing graduating students only.

 California Career Institute, Garden Grove, Vocational Nursing Program – Request Approved.

The Program requested to admit a part-time evening class of 45 students to commence on August 8, 2023, with a graduation date of March 16, 2025. This is a one-time additional class.

 Gurnick Academy, Concord, Psychiatric Technician Program – Request Approved.

The Program requested the voluntary removal from the list of approved schools, effective July 18, 2023.

### • National Career College, Vocational Nursing Program - Request Approved.

The Program requested to admit a full-time day class of 30 students to commence on August 21, 2023, with a graduation date of April 2, 2025, to replace the class graduating on August 17, 2023.

# Summit College, San Bernardino, Vocational Nursing Program – Requests Approved

The Program requested to admit a part-time day class of 20 students to commence on August 7, 2023, with an expected graduation date of March 16, 2024, to replace the class graduating on June 25, 2023.

The Program further requested to admit a full-time day class of 25 students to commence on September 11, 2023, with an expected graduation date of September 6, 2024, to replace the class graduating on August 11, 2023

### Effective August 1, 2023:

## Angeles College, City of Industry, Vocational Nursing Program – Requests Approved

The Program requested continued program approval.

The Program further requested a change in the curriculum from a full-time curriculum of 52 weeks to a revised full-time curriculum of 52 weeks, effective August 21, 2023, and a change in the curriculum from a part-time curriculum of 72 weeks to a revised part-time curriculum of 72 weeks, effective May 11, 2024. The proposed curriculum consists of 718 theory hours and 1,082 clinical hours totaling 1,800 hours.

#### • Bakersfield College, Vocational Nursing Program – Request Approved

The Program requested to increase the frequency of admissions from one full-time class of 60 students per calendar year, replacing graduating classes, to two full-time classes of 60 students per calendar year, replacing graduating classes, beginning January 19, 2024.

# Gurnick Academy of Medical Arts, Modesto, Vocational Nursing Program – Request Approved

The Program requested to change their pattern of admission to a total of eight classes per year, including four full-time day classes of 42 students and four full-time evening classes of 42 students.
