**Subject:** Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from November 11, 2023, to January 11, 2024.

**The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).**

**Effective November 11, 2023:**

- **Career Care Institute, Oxnard, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 40 students to commence on December 18, 2023, with a graduation date of June 10, 2025, to replace the class graduating on December 3, 2023.

- **City College of San Francisco, Vocational Nursing Program – Request Approved**

The Program requested a change in the curriculum from a full-time curriculum of 57 weeks to a revised full-time curriculum of 57 weeks, effective August 2024. The proposed curriculum consists of 622 theory hours and 972 clinical hours totaling 1594 hours.

- **North-West College, Glendale, Vocational Nursing Program – Requests Approved**

The Program requested initial approval for the four-year period beginning November 7, 2023.

The Program further requested to approval of a 60-week curriculum consisting of 682 theory hours and 954 clinical hours totaling 1636 program hours.

- **Unitek College, Hayward, Vocational Nursing Program – Requests Approved**

The Program requested to admit a full-time evening class of 36 students to commence on November 20, 2023, with a graduation date of March 14, 2025, to replace the class of students graduating on November 3, 2023.

The Program requested to admit a part-time evening class of 36 students to commence on December 12, 2023, to graduate on July 3, 2025, to replace the class of students graduating on December 2, 2023.

**Effective December 5, 2023:**

- **Allied Medical & Health Services, Inc. Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time day class of 12 students to commence on January 20, 2024, with a graduation date of July 22, 2025.

- **Contra Costa Medical Career College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 24 students to commence on January 12, 2024, with a graduation date of February 28, 2025, to replace the students who graduated on November 17, 2023.

- **Dalrada Career Institute Vocational Nursing Program – Request Approved**

The Program requested to admit an initial full-time class of 30 students to commence on February 5, 2024, with a graduation date of February 28, 2025.

- **High Desert Medical College, Temecula, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on January 15, 2024, with a graduation date of April 3, 2025, to replace the class graduating on November 27, 2023. This will be the second class for this program.

- **Imperial Valley College Vocational Nursing Program – Request Approved**

The Program requested to increase the class size from 24 students to 36 students beginning with the February 12, 2024 class start.

- **Inland Career Education Center Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **National Career College Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **North-West College, San Diego, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 45 students to commence on April 22, 2024, with a graduation date of August 4, 2025. This will be the second class for this program.

- **Nurses’ Development Center Vocational Nursing Program – Requests Approved**

The Program requested continued program approval.

The Program requested a change in the curriculum from a full-time curriculum of 48 weeks to a revised full-time curriculum of 48 weeks, and from a part-time curriculum of 85 weeks to a revised part-time curriculum of 85 weeks effective December 11, 2023. The proposed curriculum consists of 683 theory hours and 968 clinical hours totaling 1651 hours.

The Program requested to admit a full-time class of 12 students to commence on December 11, 2023, with a graduation date of December 6, 2024, to replace the class graduating on October 13, 2023.

- **Shasta College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 28 students to commence on January 16, 2024, with a graduation date of May 15, 2025, to replace the class that graduates on December 21, 2023.

- **San Joaquin Valley College, Santa Maria, Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **The Nurse Academy, Vocational Nursing Program – Requests Approved**

The Program requested continued program approval.

The Program requested to admit a part-time class of 24 students to commence on December 11, 2023, with a graduation date of July 30, 2025.

### **Effective December 19, 2023:**

- **El Monte-Rosemead Adult School, Vocational Nursing Program – Request Approved**

The Program requested voluntary closure of the vocational nursing program and removal from the list of approved schools, effective December 5, 2023.

- **Mt. San Antonio College Vocational Nursing Program – Requests Approved**

The Program requested initial approval for the four-year period beginning December 19, 2023.

The Program requested approval of the Program’s 54-week full-time curriculum, three 18-week terms of consisting of 1594 hours, including 584 theory hours and 1010 clinical hours.

The Program requested to admit a full-time day class of 24 students to commence on September 3, 2024, with a projected graduation date of October 18, 2025.

- **Summit College, El Cajon, Vocational Nursing Program – Requests Approved**

The Program requested to admit a full-time day class of 30 students to commence on January 29, 2024, with an expected graduation date January 24, 2025, to replace the class that graduated on December 5, 2023.

The Program requested to begin an initial full-time class of 45 students on June 19, 2023, graduating on March 15, 2024.

### **Effective January 11, 2024:**

- **California Career Institute, Garden Grove, Vocational Nursing Program – Requests Approved**

The Program requested to admit a part-time evening class of 45 students to commence on January 25, 2024, with a graduation date of August 3, 2025, to replace the class that graduates on December 1, 2023.

The Program requested to admit a part-time evening class of 45 students to commence on February 26, 2024, with a graduation date of October 5, 2025, to replace the class that graduates on February 23, 2024.

- **Carrington College, Sacramento, Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Carrington College, San Jose, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on February 26, 2024, with a graduation date of February 5, 2025, to replace the class graduating on February 23, 2024.

- **Los Angeles Mission College Vocational Nursing Program – Requests Approved**

The Program requested initial approval for the four-year period beginning January 11, 2024.

The Program requested approval of the Program’s 63-week full-time curriculum, of 1566 hours, including 594 theory hours and 972 clinical hours.

The Program requested to admit a full-time day class of 20 students on August 26, 2024. The projected graduation date is August 29, 2025.

- **Moriah Medical College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on March 4, 2024, with a graduation date of May 25, 2025, to replace the class that graduates on February 25, 2024.

- **National Career College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 30 students to commence on March 4, 2024, with a graduation date of July 3, 2025, to replace the class graduating on February 28, 2024.

- **Unitek College, Hayward, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 36 students to commence on February 26, 2024, with a graduation date of February 14, 2025, to replace the students who graduate February 20, 2024.

- **Unitek College, San Jose, Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time, 84-week evening class of 36 students to commence on February 26, 2024, with a graduation date of September 6, 2025, to replace the class that graduates February 17, 2024. This class is not part of the pattern of admission.
