Education Consultant Program Reports from January 23, 2024, to

April 16, 2024.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective January 23, 2024:

 Medical Allied Career Center, Vocational Nursing Program – Request Approved

The Program requested a part-time class of 20 students to commence on February 13, 2024, with a graduation date of September 7, 2025, to replace the class that graduates on February 18, 2024.

• Medical Career College, Vocational Nursing Program - Request Approved

The Program requested to admit a full-time class of 18 students to commence on January 29, 2024, with a graduation date of January 24, 2025, to replace the class that graduated on April 7, 2023.

 Summit College, San Bernardino, Vocational Nursing Program – Requests Approved

The Program requested to admit a full-time day class of 25 students to commence on January 29, 2024, with an expected graduation date of January 24, 2025, replacing the class that graduated on December 1, 2023.

Gurnick Academy of Medical Arts, Concord, Vocational Nursing Program – Requests Approved

The Program requested a change in the curriculum from a full-time curriculum of 52 weeks to a revised full-time curriculum of 48 weeks, effective July 1, 2024. The proposed curriculum consists of 576 theory hours and 954 clinical hours totaling 1530 hours.

The Program requested a change in the curriculum from a full-time curriculum of 52 weeks to a revised full-time curriculum of 48 weeks, effective July 1, 2024. The proposed curriculum consists of 576 theory hours and 954 clinical hours totaling 1530 hours.

Gurnick Academy of Medical Arts, San Jose, Vocational Nursing Program – Requests Approved

The Program requested a change in the curriculum from a full-time curriculum of 52 weeks to a revised full-time curriculum of 48 weeks, effective July 1, 2024. The

proposed curriculum consists of 576 theory hours and 954 clinical hours totaling 1530 hours.

The Program further requested to revise their pattern of admission to include two full-time day classes of 42 students and two full-time evening classes of 42 students, replacing graduating classes only, for a total of four classes per year.

Los Angeles Mission College, Vocational Nursing Program – Request Approved

The Program requested a change in hours for the Program's full-time 63-week curriculum. The new curriculum will decrease the program hours by 36 hours from 1566 to 1530 hours. The curriculum will consist of 576 theory hours and 954 clinical hours totaling 1530 hours, effective March 19, 2024.

North-West College, Anaheim, Vocational Nursing Program – Requests Approved

The Program requested continued Program Approval.

The Program further requested to admit a class of 30 students commencing on April 29, 2024, with a graduation date of June 12, 2025, to replace the class that graduated on February 16, 2024.
