STAFFING:

The Enforcement Division currently has an open Staff Services Analyst/Associate Governmental Program Analyst in the Probation Unit and an open Program Technician III in the Licensee Applicant Case Review Unit.

STATISTICAL OVERVIEW:

Attached is the BVNPT Enforcement Report - This report includes statistical data from 2018 to present.

NOTABLE HIGHLIGHTS:

Total Number of Investigations Assigned

The total number of cases assigned for investigation in the 2024/2025 FY, quarter two, is 612, which is up from last quarter’s 528 cases assigned.

Total Number of Pending Cases

The total number of pending investigation cases is 1,354. Of these cases, 842 of them are desk cases, which include criminal cases. The rest of the cases are sworn and non-sworn investigations.

Total Number of Investigations Completed

The total number of investigations completed in the 2024/2025 FYI, quarter two, is 496. This is down from quarter one which saw 538 cases closed.

The average number of days to complete investigations is 182 days, well within the target of 360 days.

Total Number of Cases Referred to the Attorney General’s Office

The total number of cases sent to the Attorney General’s office for formal discipline was 93 in the 2024/2025FY, quarter two.

Total Number of Disciplinary Cases Completed

The total number of disciplinary cases completed was 48 in the 2024/2025 FY, quarter two.

Licensees on Probation

During the 2024/2025 FY, quarter two, there were 28 new probationers. The average number of days from assignment to first contact was 1 day. Well within the target of 15 days.

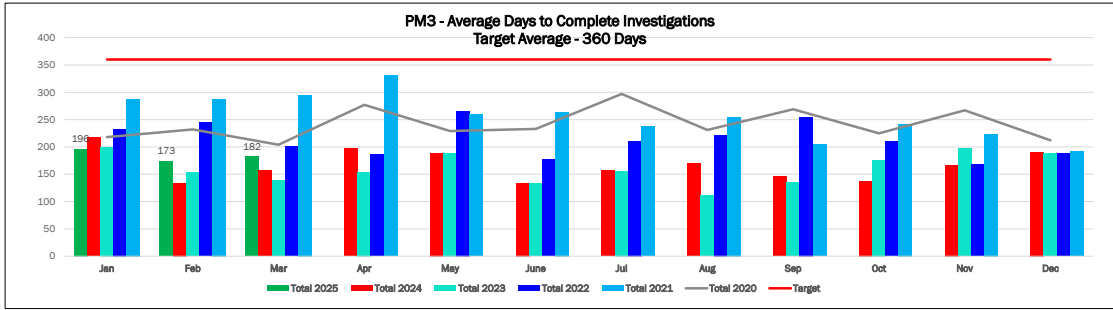
