Subject: Executive Officer Review Decisions Report of Board Nursing Education Consultant Program Reports from January 15, 2025, to April 1, 2025.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

Effective January 7, 2025:

- **Career Development Institute Inc. Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Carrington College, San Jose, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on February 10, 2025, with a graduation date of January 23, 2026. This will replace the class that graduated on February 7, 2025.

- **Dalrada Career Institute Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on March 10, 2025, with a graduation date of April 10, 2026. This will be the second class for this program.

- **Genesis Medical College Vocational Nursing Program – Requests Approved**

The Program requested approval for a Vocational Nursing Program beginning January 7, 2025.

The Program further requested approval of a 48-week curriculum to include three 16-week terms of 1530 hours, which includes 575 theory and 954 clinical hours.

The Program further requested to admit an initial class of 30 students on May 5, 2025, with a graduation date of April 27, 2026.

- **Lotus Medical Career College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 26 students to commence on April 7, 2025, with a graduation date of March 31, 2026. This will be the second class for this program.

- **Medical Allied Career Center Inc. Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time class of 20 students to commence on February 10, 2025, with a graduation date of September 26, 2026.

- **North-West College, Anaheim, Vocational Nursing Program – Request Approved**

The Program requested to increase the class size from 30 to 45 students, four times a year. This increase began with the cohort starting March 17, 2025.

- **Sri Sai Krish Institute Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Unitek College, Fremont, Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

Effective January 28, 2025:

- **Allied Medical & Health Services Inc. Vocational Nursing Program – Requests Approved**

The Program requested continued program approval.

The Program further requested a pattern of admission for one part-time day class of 12 students two times a year, only replacing graduating students.

The Program further requested to admit a part-time day, weekend class of 10 students on February 8, 2025, with a graduation date of August 11, 2026. This will replace the class that graduated on February 15, 2025.

- **Modesto Junior College Vocational Nursing Program – Requests Approved**

The Program requested approval for a Vocational Nursing Program.

The Program further requested approval of a 68-week curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 program hours.

The Program further requested to admit an initial class of 30 students on August 25, 2025, with a graduation date of April 30, 2027.

- **Napa Valley Vocational Nursing Program – Request Approved**

The Program requested voluntary removal from the list of approved schools, effective January 28, 2025.

- **Nurses’ Development Center, Inc., Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 12 students to commence on March 3, 2025, with a graduation date of March 27, 2026. This will replace the class that graduated on December 6, 2024.

- **St. Raphael Nursing School Vocational Nursing Program – Requests Approved**

The Program requested approval for a Vocational Nursing Program.

The Program further requested approval of a 60-week curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 program hours.

Effective February 4, 2025:

- **All Healthcare Institute Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 32 students to commence on March 24, 2025, with a graduation date of May 15, 2026. This will be the first class.

- **Career Care Institute, Oxnard, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time evening class of 20 students to commence on March 24, 2025, with a graduation date of July 19, 2026. This will replace the class that graduated on February 14, 2025.

- **Carrington College, Visalia, Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Contra Costa Medical Career College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 24 students to commence on March 31, 2025, with a graduation date of May 8, 2026. This will replace the class that graduated on February 28, 2025.

- **North-West College, San Diego, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 45 students to commence on May 5, 2025, with a graduation date of August 24, 2026.

Effective February 18, 2025:

- **Quest Nursing Education Center Vocational Nursing Program – Requests Deferred to the Board**

The Program requested to admit a part-time day class of 30 students to commence on March 3, 2025, with a graduation date of June 30, 2026. This will replace the class that graduated on December 20, 2024.

The Program further requested to admit a part-time evening class of 30 students to commence on March 3, 2025, with a graduation date of June 30, 2026. This is an additional class request.

- **Angeles College, Los Angeles, Vocational Nursing Program – Request Approved**

The Program requested a change in the curriculum from a full-time curriculum of 52 weeks to a revised full-time curriculum of 44 weeks. The Program will have four 11-week terms. The proposed curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 hours.

- **Annenberg School of Nursing, Los Angeles, Vocational Nursing Program – Requests Approved**

The Program requested approval for a Vocational Nursing Program.

The Program further requested approval of a 44-week curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 program hours.

The Program further requested to admit an initial full-time class of 24 students on July 14, 2025, with a graduation date of July 24, 2026.

- **Hartnell College Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Institute of Technology, Clovis, Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

Platt College, Riverside, Vocational Nursing Program – Request Approved

The Program requested to admit a part-time evening, weekend class of 24 students to commence on July 16, 2025, with a graduation date of May 10, 2027. This class will replace the initial class that graduated on April 30, 2024.

- **Stanbridge University, San Diego, Vocational Nursing Program – Requests Approved**

The Program requested approval for a Vocational Nursing Program.

The Program further requested approval of a 60-week curriculum consisting of 576 theory hours and 954 clinical hours, totaling 1530 hours.

The Program further requested to admit an initial full-time class of 45 students on March 24, 2025, with a graduation date of September 25, 2026.

Effective March 4, 2025:

- **California Healthcare Skills Center Vocational Nursing Program – Request Deferred to the Board**

The Program requested to admit a full-time class of 15 students to commence on March 10, 2025, with a graduation date of March 8, 2025. This will replace the class that graduated on September 30, 2024. This will be the Program's third class.

- **Concorde Career College, San Diego, Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Feather River College Vocational Nursing Program – Requests Approved**

The Program requested continued program approval.

The Program further requested a change in the curriculum from a part-time two-year curriculum of 1548.5 hours to 1530 hours, effective March 4, 2025. The proposed curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 hours.

- **Gurnick Academy of Medical Arts, Sacramento, Vocational Nursing Program – Requests Approved**

The Program requested to add a hybrid curriculum. The curriculum will be a full-time curriculum consisting of 48 weeks and will have four 12-week terms. The proposed curriculum consists of 576 theory hours and 954 clinical hours, totaling 1530 hours.

The Program further requested to admit a class of 30 full-time students to commence on March 31, 2025, with a graduation date of March 27, 2026. Fifteen students will be in a day class and 15 students will be in an evening class. This will be an additional class and not part of the Program's pattern of admission.

- **High Desert Medical College, Temecula, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on April 14, 2025, with a graduation date of July 29, 2026. This will be the fifth class for this program, the third full-time class.

- **Marian College, Los Angeles, Vocational Nursing Program – Requests Approved**

The Program requested to admit a full-time class of 15 students to commence on March 25, 2025, with a graduation date of June 10, 2026, to replace the class that graduated on February 5, 2025.

The Program further requested to admit a part-time class of 15 students to commence on April 17, 2025, with a graduation date of December 12, 2026, to replace the class that graduated on April 17, 2025.

- **Nurses' Development Center, Inc., Vocational Nursing Program – Request Approved**

The Program requested to a part-time day class of 12 students to commence on April 7, 2025, with a graduation date of November 22, 2026.

Effective March 19, 2025:

- **CNI College Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on May 13, 2025, that will graduate on May 27, 2026. This will replace the class that graduated on March 15, 2025.

- **Hacienda La Puente Adult Education Vocational Nursing Program – Request Approved**

The Program requested continued program approval.

- **Pacific College, Costa Mesa, Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time evening class of 25 students to commence on March 24, 2025, with a graduation date of January 3, 2027. This will replace the class that graduated on March 17, 2025.

Effective April 1, 2025:

- **California Career Institute, Anaheim, Vocational Nursing Program – Request Approved**

The Program requested to admit a part-time evening class of 45 students to commence on May 6, 2025, with a graduation date of November 15, 2026. This will replace the class that graduated on March 14, 2025.

- **California Nurses Educational Institute Vocational Nursing Program – Request Approved**

The Program requested a change in the curriculum from a full-time curriculum of 60 weeks to a revised full-time curriculum of 60 weeks, effective April 1, 2025. The proposed curriculum consists of 576 theory hours and 954 clinical hours totaling 1530 hours.

- **Career Care Institute, Moreno Valley, Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time day class of 35 students to commence on May 19, 2025, with a graduation date of September 6, 2026. This will replace the class that graduated on May 11, 2025.

- **Downey Adult School Vocational Nursing Program – Request Approved**

The Program requested to admit a full-time class of 30 students to commence on May 19, 2025, with a graduation date of May 14, 2026. This will replace the class

that graduated on May 15, 2025.

- **San Joaquin Delta College Psychiatric Technician Program – Request Approved**

The Program requested to admit a full-time class of 40 students to commence on May 20, 2025, with a graduation date of June 15, 2026. This will replace the class that graduated on June 13, 2025.
