Subject: Executive Officer Review Decisions Report of Board Nursing

Education Consultant Program Reports from April 17, 2025, to July

22, 2025.

The Executive Officer took the following actions related to vocational nursing and psychiatric technician programs (Programs).

## Effective April 17, 2024:

 Career Care Institute, Oxnard, Vocational Nursing Program – Request Approved

The Program requested to admit a full-time day class of 20 students on June 16, 2025, with a graduation date of October 4, 2026. This replaced the class that graduated on April 27, 2025.

 Carrington College, San Jose, Vocational Nursing Program – Request Approved

The Program requested to admit a full-time class of 30 students to commence on June 9, 2025, with a graduation date of May 29, 2026.

 Concorde Career College, San Bernardino, Vocational Nursing Program – Request Approved

The Program requested continued program approval.

 High Desert Medical College, Bakersfield, Vocational Nursing Program – Request Approved

The Program requested to admit a full-time class of 20 students to commence April 28, 2025, with a graduation date of August 11, 2026. This replaced the class that graduated on April 16, 2025.

# Project Heartbeat College Vocational Nursing Program – Requests Approved

The Program requested initial program approval for a four-year period beginning April 15, 2025.

The Program further requested approval of a 47-week full-time curriculum, one 14-week term, one 15-week term and one 18-week term. The proposed curriculum consists of 576 theory hours and 954 clinical hours totaling 1530 program hours.

The Program further requested to admit a full-time class of 20 students on September 15, 2025, and graduating September 2, 2026. This is an initial class.

The Program requested continued program approval.

 Medical Allied Career College, Inc., Vocational Nursing Program – Request Approved

The Program requested to admit a part-time class of 20 students to commence on June 10, 2025, with a graduation date of January 24, 2027. This replaced the class that graduated on April 6, 2025.

Moriah Medical College Vocational Nursing Program – Requests Approved

The Program requested continued program approval.

The Program further requested a pattern of admission to include one full-time class of 30 students every 15 months, alternating between day and evening classes, only, replacing graduating classes.

The Program further requested a change in the curriculum from a full-time curriculum of 60 weeks to a revised full-time curriculum of 60 weeks, effective April 29, 2025. The proposed curriculum consists of 576 theory hours and 954 clinical hours totaling 1530 hours.
