Staffing

The Enforcement Division currently has an open Analyst II position in the Probation Unit and Program Technician III in the Licensee Applicant Case Review Unit (LACRU).

Statistical Overview

Attached is the BVNPT Enforcement Report - This report includes statistical data from 2018 to present.

Total Number of Cases Received

The total number of cases received in the second quarter was 695.

Total Number of Pending Cases

The total number of pending investigations for the second quarter was 1385.

Total Number of Investigations Completed

The total number of investigations completed in the second quarter was 676.

The average number of days to complete investigations is 207 days, well within the target of 360 days.

Total Number of Cases Referred to the Attorney General's Office

The total number of cases sent to the Attorney General's office for formal discipline in the second quarter was 77.

Total Number of Disciplinary Cases Completed

The total number of disciplinary cases completed in the second quarter was 44.

Licensees On Probation

There are currently current 350 licensees on probation.

Enforcement Committee

The Enforcement Division has recently proposed the idea that the Enforcement Committee become the Consumer Protection Committee which would encompass the existing Enforcement Committee and Licensing Committee. This committee would be responsible for Enforcement, Licensing, and Special Investigations oversight. This committee would allow staff from each division to work together more collaboratively to protect consumers and work on issues that our licensees face.
