EXECUTIVE SUMMARY

The Board of Vocational Nursing and Psychiatric Technicians (Board) requested that the Department of Consumer Affairs' Office of Professional Examination Services (OPES) conduct an occupational analysis (OA) of the Psychiatric Technician (PT) profession in California. The purpose of the OA is to define practice for PTs in terms of critical tasks that newly licensed PTs must be able to perform safely and competently at the time of licensure. The results of this OA provide the basis for developing a valid and legally defensible PT licensure examination in California.

OPES test specialists began by researching the profession and conducting telephone interviews with licensed PTs working in locations throughout California. The purpose of these interviews was to identify the tasks performed by PTs and to specify the knowledge required to perform those tasks in a safe and competent manner. Using the information gathered from the research and the interviews, OPES test specialists developed a preliminary list of tasks performed by PTs in their profession along with statements representing the knowledge needed to perform those tasks.

In March 2019, OPES convened a workshop to review and refine the preliminary lists of task and knowledge statements describing the practice of PTs in California. The workshop was comprised of licensed PTs, or subject matter experts (SMEs), with diverse backgrounds in the profession (i.e., practice settings, practice location, years licensed). A second workshop was held in April 2019 to review the results from the initial workshop and to finalize the task and knowledge statements. The SMEs also developed the demographic questions for the OA questionnaires, reviewed the rating scales to be used for rating task statements, and linked each task statement with the knowledge statements used in the performance of that task.

Upon completion of the workshop, OPES test specialists developed a two-part OA questionnaire to be completed by PTs statewide. Development of the OA questionnaire included a pilot study that was conducted using a group of PTs who had participated in the March and April 2019 workshops. The pilot study participants' feedback was incorporated into the final questionnaire, which was administered from July 24 to September 5, 2019.

In the first part of the OA questionnaire, PTs were asked to provide demographic information related to their work settings and practice. In the second part, PTs were asked to rate specific tasks in terms of frequency (i.e., how often the PT performs the task in the PT's current job) and importance (i.e., how important the task is to effective performance of the PT's current job).

In July 2019, on behalf of the Board, OPES sent an email to a sample of 2,079 actively licensed PTs with a California address (23% of the total population of 9,057 actively licensed PTs with a California address), asking them to complete the online OA questionnaire. The email invitation was sent to PTs with a California address for whom the Board had an email address on file. The Board also sent an email to the Board's subscriber list announcing the OA and providing a link to the survey. Reminder emails were sent to licensed PTs two weeks and again three weeks after the initial contact was made.

A total of 825 PTs responded by accessing the online OA questionnaire. The final sample size included in the data analysis was 486, or approximately 5% of the licensed population. This response rate reflects two adjustments. First, OPES excluded data from respondents who indicated they were not currently licensed and working as PTs in California. Second, OPES removed data from respondents who provided only demographic information but did not complete any task statements.

OPES test specialists then performed data analyses on the task ratings obtained from the questionnaire respondents. The task frequency and importance ratings were combined to derive an overall criticality index for each task statement. The mean importance rating was used as the criticality index for each knowledge statement.

Once the data were analyzed, OPES conducted an additional workshop with SMEs in September 2019. The SMEs evaluated the criticality indices and determined whether any task statements should be excluded from the examination outline based on low ratings. The SMEs in this group also established the final linkage between tasks and knowledge statements, organized the task and knowledge statements into content areas, and defined those content areas. OPES test specialists presented SMEs with preliminary content area weights. The SMEs then evaluated the preliminary content area weights and determined the final weights for the new examination outline.

The new examination outline is structured into seven content areas weighted by criticality relative to the other content areas. The new outline identifies the tasks and knowledge critical to safe and effective PT practice in California at the time of licensure.

The examination outline developed as a result of this OA provides a basis for developing a written examination for inclusion in the process of PT licensure. At this time, California licensure as a PT is granted by meeting the training requirements and passing the California Psychiatric Technician Licensure Examination.

CHAPTER 1 | INTRODUCTION

PURPOSE OF THE OCCUPATIONAL ANALYSIS

The Board of Vocational Nursing and Psychiatric Technicians (Board) requested that the Department of Consumer Affairs' Office of Professional Examination Services (OPES) conduct an occupational analysis (OA) as part of the Board's comprehensive review of the Psychiatric Technician (PT) profession in California. The purpose of the OA is to define PT practice in terms of critical tasks that newly licensed PTs must be able to perform safely and competently at the time of licensure. The results of this OA provide a description of practice for the PT profession that can then be used to develop the California Psychiatric Technician Licensure Examination.

PARTICIPATION OF SUBJECT MATTER EXPERTS

The Board selected California PTs to participate as subject matter experts (SMEs) during all phases of the OA to ensure that the description of practice directly reflects current PT work requirements in California. The SMEs were selected from a wide range of work settings, geographic locations, and experience backgrounds. The SMEs provided technical expertise and information regarding different aspects of current PT practice during various phases of the OA, including interviews and workshops. During interviews, the SMEs provided information about tasks and the knowledge required to perform those tasks safely and competently. During workshops, the SMEs developed and reviewed the task and knowledge statements describing the PT profession, identified knowledge used in performance of each task, organized the task and knowledge statements into meaningful content areas, evaluated results of the OA, and developed the examination content outline.

ADHERENCE TO LEGAL STANDARDS AND GUIDELINES

Licensing, certification, and registration programs in the State of California adhere to federal and state laws and regulations, as well as to professional guidelines and technical standards. For the purpose of OAs, the following laws and guidelines are authoritative:

- California Business and Professions Code section 139.
- Uniform Guidelines on Employee Selection Procedures (1978), Code of Federal Regulations, Title 29, Section 1607.
- California Fair Employment and Housing Act, Government Code section 12944.
- Principles for the Validation and Use of Personnel Selection Procedures (2018), Society for Industrial and Organizational Psychology (SIOP).
- Standards for Educational and Psychological Testing (2014), American Educational Research Association, American Psychological Association, and National Council on Measurement in Education.

For a licensure examination to meet these standards, it must be solidly based upon the activities required for practice.

DESCRIPTION OF OCCUPATION

The psychiatric technician occupation is described in California Business and Professions Code (BPC) sections 4502, 4502.1, 4502.2, and 4502.3 and in title 16 of the California Code of Regulations (16 CCR), sections 2576.5, 2576.6, and 2576.7.

BPC §4502:

As used in this chapter, "psychiatric technician" means any person who, for compensation or personal profit, implements procedures and techniques that involve understanding of cause and effect and that are used in the care, treatment, and rehabilitation of mentally ill or emotionally disturbed persons, or persons with intellectual disabilities, and who has one or more of the following:

(a) Direct responsibility for administering or implementing specific therapeutic procedures, techniques, treatments, or medications with the aim of enabling recipients or patients to make optimal use of their therapeutic regime, their social and personal resources, and their residential care.

(b) Direct responsibility for the application of interpersonal and technical skills in the observation and recognition of symptoms and reactions of recipients or patients, for the accurate recording of these symptoms and reactions, and for the carrying out of treatments and medications as prescribed by a licensed physician and surgeon or a psychiatrist.

The psychiatric technician in the performance of these procedures and techniques is responsible to the director of the service in which his or her duties are performed. The director may be a licensed physician and surgeon, psychiatrist, psychologist, rehabilitation therapist, social worker, registered nurse, or other professional personnel.

Nothing herein shall authorize a licensed psychiatric technician to practice medicine or surgery or to undertake the prevention, treatment, or cure of disease, pain, injury, deformity, or mental or physical condition in violation of the law.

BPC §4502.1:

A psychiatric technician, working in a mental health facility or developmental disability facility, when prescribed by a physician and surgeon, may administer medications by hypodermic injection.

BPC §4502.2:

A psychiatric technician, when prescribed by a physician and surgeon, may withdraw blood from a patient with a mental illness or developmental disability if the psychiatric technician has received certification from the board that the psychiatric technician has completed a prescribed course of instruction approved by the board or has demonstrated competence to the satisfaction of the board.

BPC §4502.3:

(a) A psychiatric technician, when prescribed by a physician and surgeon, may perform the following activities on a patient with a mental illness or developmental disability:

(1) Tuberculin, coccidioidin, and histoplasmin skin tests, providing the administration is within the course of a tuberculosis control program.

(2) Immunization techniques, providing the administration is upon the standing orders of a supervising physician and surgeon or pursuant to written guidelines adopted by a hospital or medical group with whom the supervising physician and surgeon is associated.

(b) In performing activities pursuant to subdivision (a), the psychiatric technician shall satisfactorily demonstrate competence in all of the following:

(1) Administering the testing or immunization agents, including knowledge of all indications and contraindications for the administration of the agents.

(2) Recognizing any emergency reactions to the agent that constitute a danger to the health or life of the patient.

(3) Treating those emergency reactions by using procedures, medication, and equipment within the scope of practice of the psychiatric technician.

16 CCR §2576.5:

The licensed psychiatric technician performs services requiring technical and manual skills which include the following:

(a) Uses and practices basic assessment (data collection), participates in planning, executes interventions in accordance with the care plan or treatment plan, and contributes to evaluation of individualized interventions related to the care plan or treatment plan.

(b) Provides direct patient/client care by which the licensee:

(1) Performs basic nursing services as defined in subdivision (a);

(2) Administers medications;

(3) Applies communication skills for the purpose of patient/client care and education; and

(4) Contributes to the development and implementation of a teaching plan related to self-care for the patient/client.

16 CCR §2576.6:

(a) A licensed psychiatric technician shall safeguard patients'/clients' health and safety by actions that include but are not limited to the following:

(1) Reporting to the Board acts specified in Section 4521 of the Business and Professions Code;

(2) Documenting patient/client care in accordance with standards of the profession; and

(3) Performing services in accordance with Section 125.6 of the Business and Professions Code.

(b) A licensed psychiatric technician shall adhere to standards of the profession and shall incorporate ethical and behavioral standards of professional practice which include but are not limited to the following:

(1) Maintaining current knowledge and skills for safe and competent practice;

(2) Maintaining patient/client confidentiality;

(3) Maintaining professional boundaries with the patient/client;

(4) Abstaining from chemical/substance abuse; and

(5) Cooperating with the Board during investigations as required by Section 4521.2 of the Business and Professions Code.

(c) A violation of this section constitutes unprofessional conduct for purposes of initiating disciplinary action.

16 CCR §2576.7:

Private duty patient care is care provided to patients with mental disorders or developmental disabilities and may be performed in any setting, including, but not limited to, acute care, long term care, or the patient's home. For purposes of licensure equivalency eligibility, the Board will accept only private duty patient care that has occurred in acute or long term care facilities. Private duty patient care is contracted directly between the psychiatric technician (PT) and patient or entity acting on the patient's behalf. A PT must provide private duty patient care under the direction of a registered nurse who directs nursing care, the patient's physician who directs medical care, or be responsible to the director of the service in which the duties are performed. The director may be a licensed physician and surgeon, psychiatrist, psychologist, rehabilitation therapist, social worker, registered nurse, or other professional personnel. The registered nurse, physician or director of the service must be responsible for direction to the private duty PT regarding the respective nursing and medical procedures. The direction provided must be available at least by telephone.

CHAPTER 2 | OCCUPATIONAL ANALYSIS QUESTIONNAIRE

SUBJECT MATTER EXPERT INTERVIEWS

The Board provided OPES with a list of PTs to contact for telephone interviews. Semi-structured interviews were conducted with 13 PTs. During the interviews, the PTs were asked to identify major content areas of practice and the tasks performed in each content area. The PTs were also asked to identify the knowledge necessary to perform each task safely and competently.

TASK AND KNOWLEDGE STATEMENTS

OPES test specialists developed a preliminary list of task and knowledge statements by integrating the information gathered from literature reviews of profession-related sources (e.g., previous OA reports, articles, industry publications) and from interviews with PT SMEs. The statements were organized into major content areas of practice.

In March 2019 and April 2019, OPES test specialists facilitated two workshops to evaluate and develop the task and knowledge statements. Six SMEs from diverse backgrounds (e.g., years licensed, practice setting, and geographic location) participated in each workshop, with two of the SMEs participating in both workshops. During the two workshops, SMEs evaluated the task and knowledge statements for technical accuracy, level of specificity, and comprehensiveness of assessment of the practice domain. Also, SMEs evaluated the organization of task statements into content areas to ensure that content areas were independent and non-overlapping.

During the second workshop, the SMEs also performed a preliminary linkage of the task and knowledge statements. The linkage was performed to identify the knowledge required for performance of each task and to verify that each knowledge is critical for safe and effective performance as a PT. Additionally, the linkage ensured that all task statements were linked to at least one knowledge statement and that each knowledge statement was linked to at least one task statement. During this workshop, SMEs also reviewed and revised the proposed demographic questions for the OA questionnaire and evaluated the scales that would be used for rating task statements.

OPES used the finalized list of task statements, demographic questions, and ratings scales to develop an online questionnaire that was sent to a sample of California PTs.

QUESTIONNAIRE DEVELOPMENT

OPES test specialists developed an online OA questionnaire designed to solicit PT ratings of the task statements. The surveyed PTs were instructed to rate each task in terms of how often they performed the task in their current work (Frequency) and in terms of how important the task is for effective performance of their current work (Importance). The OA questionnaire also included a demographic section to obtain relevant professional background information about responding PTs. The OA questionnaire can be found in Appendix E.

PILOT STUDY

Before administering the final questionnaire, OPES conducted a pilot study of the online questionnaire. The online questionnaire was reviewed by Board staff and then by seven SMEs who had participated in the March and April 2019 workshops. The SMEs reviewed the task statements in the questionnaire for technical accuracy and for whether they reflect the full PT practice domain. The SMEs also provided the estimated time for completion and reviewed the online navigation and ease of use of the questionnaire. OPES used this feedback to prepare the final questionnaire, which was administered from July 24 to September 5, 2019.

CHAPTER 3 | RESPONSE RATE AND DEMOGRAPHICS

SAMPLING STRATEGY AND RESPONSE RATE

In July 2019, on behalf of the Board, OPES sent an email to a sample of 2,079 actively licensed PTs with a California address (23% of the total population of 9,057 actively licensed PTs with a California address), asking them to complete the online OA questionnaire. The email invitation was sent to PTs with a California address for whom the Board had an email address on file. The email invitation is displayed in Appendix D.

The Board also distributed an email via the Board's subscriber list announcing the OA and providing a link to the online questionnaire. Reminder emails were sent to licensed PTs two weeks and again three weeks after the initial contact was made.

A total of 825 PTs responded by accessing the online OA questionnaire. The final sample size included in the data analysis was 486, or approximately 5% of the licensed population. This response rate reflects two adjustments. First, OPES excluded data from respondents who indicated they were not currently licensed and working as PTs in California. Second, OPES removed data from respondents who provided only demographic information but did not complete any task statements.

DEMOGRAPHIC SUMMARY

Tables 1–13 and Figures 1–13 display respondent demographic information.

As shown in Table 1 and Figure 1, the responding PTs reported a wide range of experience levels, and the number of respondents was relatively equally distributed across the predefined experience level categories. Most notably, a large proportion of the respondents (29%) were newly licensed. Specifically, 7% reported 12 months of licensed experience or less, and an additional 22% reported 1-5 years of licensed experience.

Table 2 and Figure 2 show that the majority of respondents (86%) reported working 40 hours per week or more, with 23% of those respondents working more than 50 hours per week. The majority of respondents indicated that they work the day shift (see Table 3 and Figure 3) and that their shift is typically 8 hours long (see Table 4 and Figure 4).

According to Table 5 and Figure 5, 72% of responding PTs reported being employed by the State of California, with private for-profit industry being the second largest employer (10%) among responding PTs. However, PTs also reported working for local governments (8%), private not-for-profit employers (8%), and the federal government (less than 1%).

Table 6 and Figure 6 indicate that responding PTs reported working predominantly in urban locations (69%). The majority reported having completed a PT program (47%), an associate degree (31%), or a bachelor's degree (14%) (see Table 7 and Figure 7). As shown in Table 8 and Figure 8, slightly fewer than half of the responding PTs reported supervising other staff.




FIGURE 11 – MOST COMMON CLIENT DIAGNOSIS

Responding PTs indicated working in a variety of professional settings, with the most represented settings being long-term psychiatric (32%), acute psychiatric (18%), and correctional or detention (17%) (see Table 9 and Figure 9). Table 10 and Figure 10 show that PTs reported working with clients aged 31 to 64 most commonly (88% of respondents). Also, 45% of PTs reported working with young adults (ages 19 to 30) and 36% reported working with older adults (ages 65 or older). Very few PTs reported working with newborns (less than one-half percent), infants and children up to 12 years of age (3%), and adolescents (6%). Table 11 and Figure 11 show that the majority of PTs (48%) reported working with clients with a dual diagnosis involving mental illness and substance abuse. The next most common client diagnosis was mental illness (33% of responding PTs).

Table 12 and Figure 12 indicate that the majority of respondents reported having no other stateissued occupational licenses or professional certifications (70%). Among reported licenses or certifications, Certified Nurse Assistant was the most common (11%).


Table 13 and Figure 13 show what respondents reported as their primary work location. Most notably, Riverside county and vicinity (32%) and San Joaquin Valley (23%) were most often reported as the primary work location, with Los Angeles county and vicinity and the San Francisco Bay Area the next most reported, with 19% and 11% respectively.

TABLE 2 – HOURS WORKED PER WEEK AS A PSYCHIATRIC TECHNICIAN






FIGURE 4 – TYPICAL SHIFT LENGTH



FIGURE 5 – CURRENT EMPLOYER




FIGURE 7 – HIGHEST LEVEL OF EDUCATION ACHIEVED



FIGURE 8 – NUMBER OF STAFF SUPERVISED




FIGURE 10 – CLIENT AGE








CHAPTER 4 | DATA ANALYSIS AND RESULTS

RELIABILITY OF RATINGS

OPES evaluated the task ratings obtained by the questionnaire with a standard index of reliability, coefficient alpha (α), which ranges from 0 to 1. Coefficient alpha is an estimate of the internal consistency of the respondents' ratings of the task and knowledge statements. A higher coefficient value indicates more consistency between respondent ratings. Coefficients were calculated for all respondent ratings.

Table 14 displays the reliability coefficients for the task statement ratings overall and for each content area. The overall ratings of task frequency and task importance across content areas were highly reliable (frequency α = .99; importance α = .99). These results indicate that the responding PTs rated the task statements consistently throughout the questionnaire.

TASK CRITICALITY INDICES

OPES convened a workshop consisting of seven PT SMEs in September 2019. The purpose of this workshop was to identify the essential tasks and knowledge required for safe and effective PT practice at the time of licensure.

To identify the essential tasks, the SMEs reviewed the mean frequency rating, mean importance rating, and the criticality index for each task. To calculate the criticality index of each task statement, OPES used the following formula:

Task criticality index = mean [(Fi) X (li)]

For each respondent, OPES first multiplied the frequency rating (Fi) and the importance rating (Ii) of each task. Next, OPES averaged the multiplication products across respondents.

The task statements were sorted in descending order of their criticality index. The task statements, their mean frequency and importance ratings, and their associated criticality indices are presented in Appendix B.

The SMEs who participated in the September 2019 workshop evaluated the task criticality indices derived from the questionnaire results. OPES test specialists instructed the SMEs to determine if any of the tasks had a criticality index that was too low for the task to be retained. Based on their review of the relative importance of tasks to PT practice, the SMEs agreed that all tasks had criticality indices that were high enough to be considered critical for entry-level performance and should, therefore, remain in the examination outline.

KNOWLEDGE STATEMENTS

The SMEs who participated in the September 2019 workshop reviewed the list of knowledge statements that was developed during the first two OA workshops to verify that all knowledge statements were critical for safe and effective entry-level performance as a PT in California. The SMEs agreed that all knowledge statements were critical for entry-level performance as a PT in California and should, therefore, remain in the examination outline. The knowledge statements are presented in Appendix C.

CHAPTER 5 | EXAMINATION OUTLINE

TASK-KNOWLEDGE LINKAGE

The SMEs who participated in the September 2019 workshop finalized the organization of the task and knowledge statements into content areas.

The SMEs also established the final linkage of task and knowledge statements. The SMEs worked individually to identify the knowledge base critical in effective performance of each task. They then communicated the results to the facilitator and discussed any issues until they were clarified and agreement regarding linkages was reached. Therefore, all knowledge statements included on the examination outline were linked to tasks found to be critical for entry-level practice. The table displaying the linkage of task and knowledge statements can be found in Appendix F.

CONTENT AREAS AND WEIGHTS

The SMEs in the September 2019 workshop were also asked to finalize the weights of the content areas on the PT examination outline. OPES test specialists presented the SMEs with preliminary weights of the content areas. The preliminary weights were calculated by dividing the sum of the criticality indices for the tasks in each content area by the overall sum of the criticality indices for all tasks, as shown below.

The SMEs evaluated the preliminary content area weights in terms of how well they reflected the relative importance of the content areas to entry-level PT practice in California. Through discussion, the SMEs agreed that the preliminary content area weights for most content areas accurately captured the relative importance of the content areas to PT practice in California. They also determined that slight adjustments to content area weights were necessary for the content areas Administration of Care (area 3), Medications (area 5), and Psychosocial Assessment and Interventions (area 6) to more accurately capture the relative importance of those content areas weight for Administration of Care was reduced from 10% to 6%, the content area weight for Medications was increased from 14% to 17%, and the content area weight for Psychosocial Assessment and Interventions was increased from 21% to 22%.

The SMEs also revised knowledge statement 117 from, "Knowledge of procedures and legal requirements pertaining to documentation of assessments, interventions, and client response to care" to "Knowledge of procedures and legal requirements pertaining to documentation and reporting of assessments, interventions, and client response to care."

A summary of the preliminary and final content area weights for the PT examination outline is presented in Table 15.


